6. That the School Principal be requested to send information to parents regarding the safety of students in and around school property, emphasizing the requirement to cross safely at the signalized intersection rather than jaywalk into live traffic.

### **Observations:**

1. The intersection of Wanless Drive and Edenbrook Hill is signalized with a posted speed limit of 60km/hr on Wanless Drive, and enhanced pavement markings. All signals and crosswalk buttons functioned properly. No school age children were observed crossing the intersection; however, school buses were observed in the vicinity.
2. There is an unfinished paved walking path 120 metres east of Edenbrook Hill heading towards Queen Mary Drive, this path continues on both sides of Wanless Drive.
3. The intersection of Wanless Drive and Queen Mary Drive is signalized with enhanced pavement markings and a speed limit of 60km/hr. All signals were operational during the site visit. A few students crossed the intersection, but most were accompanied by an adult.

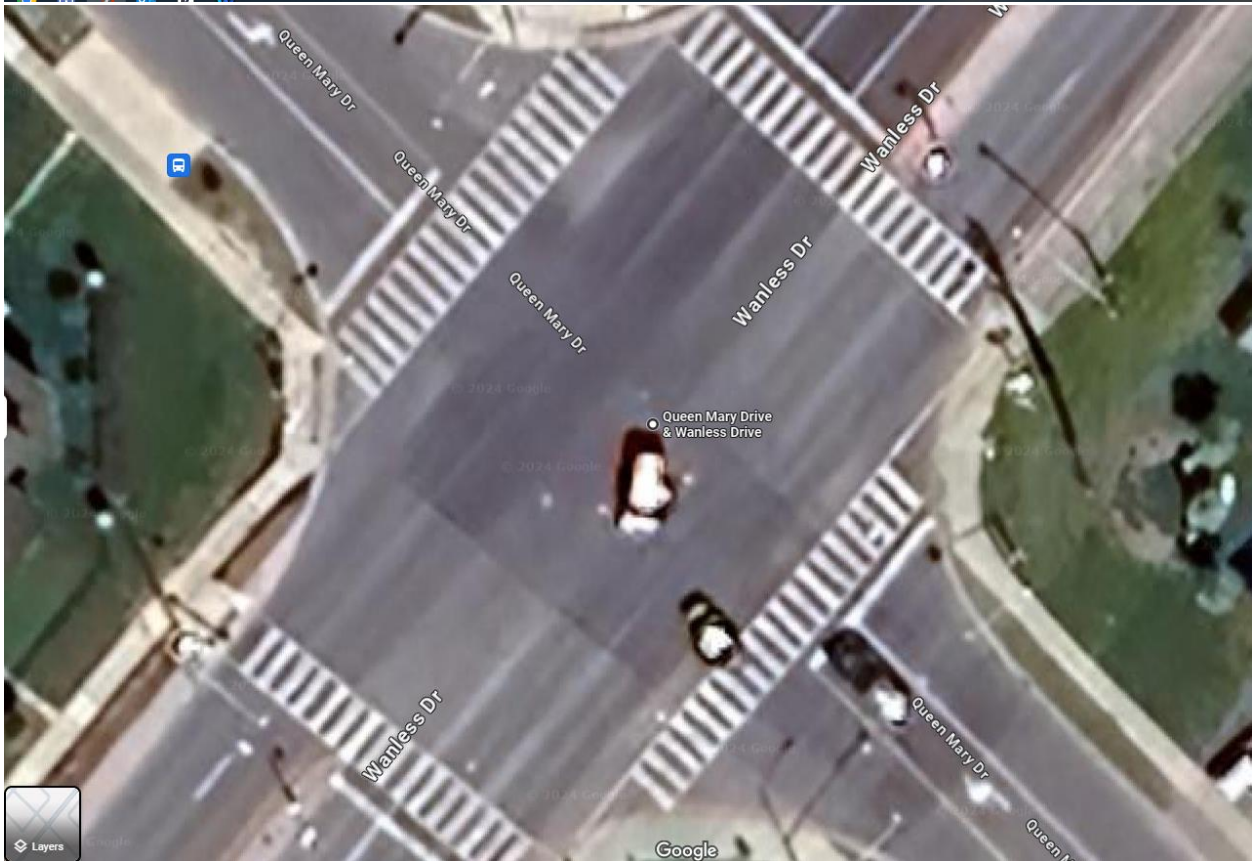
### **Recommendations:**

### Observations:

1. Mount Pleasant Village Public School is located on the east side of Commuter Drive, at the intersection of Commuter Drive and Ganton Heights. There are school signs and 40 km/hr all around the school area.
2. Traffic signals are in operation at the intersection of Commuter Drive and Ganton Heights, and at Commuter and Bleasdale Ave. The school is designated as a walking school and hence there is no Kiss and Ride or access to the parking lot for parents. Laybys are provided in the vicinity of the school to provide stopping and / or parking for parents.
3. Parking is available for the staff at the back of the school.
4. There is "No Stopping" on the west side of Commuter Drive from Bleasdale Avenue to Ganton Heights. On the school side of Commuter Drive at Ganton Heights, there is a space for three cars which is "No Parking", infringing on the crosswalk at the signals. The remainder of the east side is marked "No Stopping". Drivers stopped/parked in the No Parking/No Stopping during both inspections.
5. During the morning and afternoon inspections, approximately 60 students crossed Commuter Drive from Ganton Heights. Most students were accompanied by adults. There were no conflicts between pedestrians and vehicles.

**Recommendations:**

1. That the Site Inspection Report for Mount Pleasant Village Public School be received;
3. That the Manager of Enforcement and By-law Services, be requested to enforcing parking violations on both sides of Commuter Drive along the length of the school property; and,
4. An adult crossing guard is not warranted at the intersection of Commuter Drive and Ganton Heights at this time.

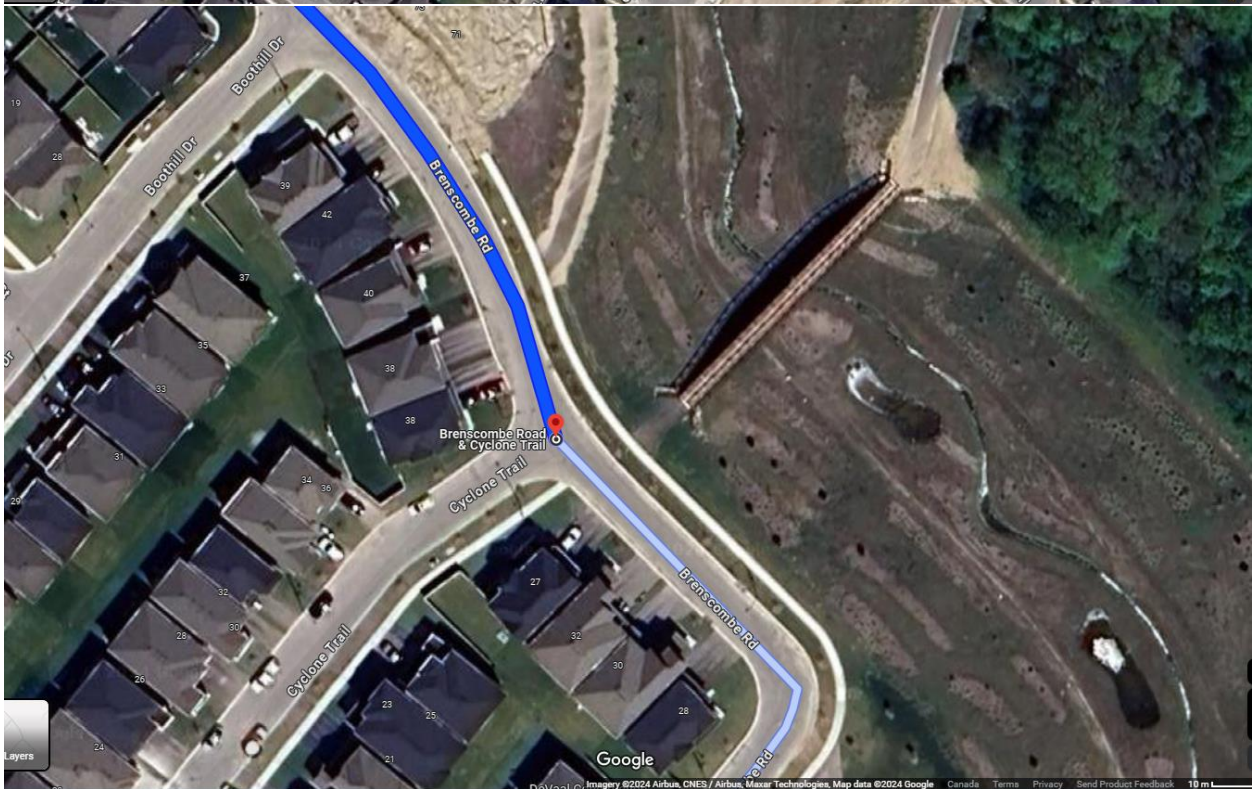
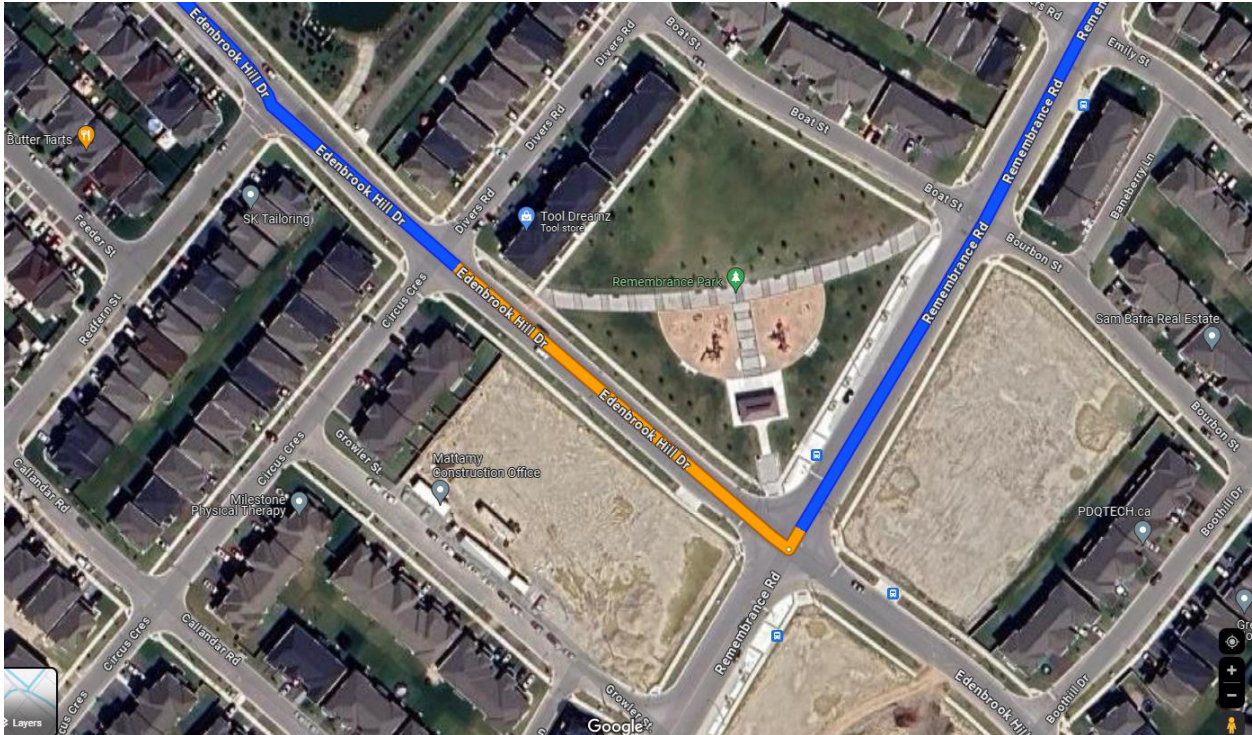
1. The pedestrian bridge adjacent to Cyclone Trail and Brenscome Road has a steel frame and wooden plank walking surface. The wooden walking surface is in good condition. The steel sides of the bridge show two rusty, sharp edges, running the length of the bridge. The shape edges are a hazard.
  2. Several metal screws to hold down metal kick plates at both ends of the bridge are missing or broken off, which could create a trip hazard.
  3. The bridge has a plaque that stipulates no salt or calcium to be used on the bridge. There is also a "not maintained during winter months" sign on the west side of the bridge.
  4. No pedestrians used the bridge during the 30-minute site-inspection.
  5. There are "no parking" signs for 10 metres to the south of the bridge entrance and approximately 25 metres to the north side of the bridge.

### **Recommendations:**

1. That the Site Inspection report for Malala Yousafzai Public School be received;
  2. That the Manager of Parks & Recreation Department arrange for an inspection of the bridge for any deficiencies and sharp edges and replace the missing screws for the kick plates on the bridge;
  3. The Manager of Parks and Recreation be requested to confirm if winter maintenance can be done on the pathway if students utilize the path as a school route.
