#### **Observations:**

- 1. Carberry Public School is located on Fernforest Drive, south of the intersection of Fernforest Drive and Abitibi Lake Road. A crossing guard is located at the south end of the school.
- 2. The intersection of Fernforest Drive and Abitibi Lake Road is an All Way stop with crosswalks on all legs of the intersection.
- 3. During the site inspection most of the students crossed Fernforest Drive; 22 crossed in the morning and 57 crossed in the afternoon. In the morning a few conflicts were observed between pedestrians and vehicle drivers while crossing traffic. In the afternoon, gaps between traffic were inadequate, resulting in increased conflicts and more aggressive behavior between pedestrians and vehicle drivers.

#### Recommendations:

- 1. That the Site Inspection report for Carberry Public School be received;
- That in an effort to encourage Active Transportation to and from school, the principal contact their designated Peel Health Nurse to participate in the School Travel Plan Program in Peel; and;
- 3. That a Crossing Guard is warranted at the intersection of Fernforest Drive and Abitibi Lake Road.

#### **Observations:**

- 1. Ridgeview Public School is located on Brenda Avenue between Harold Street and Kingsview Boulevard and the speed limit on Brenda Avenue is 40 km/hr.
- 2. The school is serviced by 5 large buses and 5 small buses. Sufficient staff was present to escort the children in a timely manner.
- 3. The posted parking restrictions on Brenda Avene are as follows: -
  - East side of Brenda Avenue indicates 'No stopping, 8-5 Mon-Fri' from Kingsview Blvd to Harold Street.
  - West side of Brenda Avenue, a new layby was installed along the school frontage and is signed 'Bus Loading Zone with 'No Parking" restrictions on either side of the layby
- 4. The school parking is located on the south side of the school and is blocked by a gate that is opened when school starts or when the buses leave.
- 5. During the afternoon inspection, many vehicles were seen parking on the east side of Brenda Avenue in the 'No Stopping' zone as well as in the 'No Parking' zone on the west side of Brenda Avenue. This created traffic congestion, which increased as students J-walked across Brenda Avenue to get to vehicles.

#### **Recommendations:**

- 1. That the Site Inspection report for Ridgeview Public School be received;
- 2. That in an effort to encourage Active Transportation to and from school, the principal contact their designated Peel Health Nurse to participate in the School Travel Plan Program in Peel;
- 3. That Peel Regional Police be requested to enforce the "No U-Turn" driving restrictions on Brenda Avenue; and
- 4. That the Manager of Enforcement and By-law Services be requested to arrange for the enforcement of parking restrictions on Brenda Avenue during school arrival and dismissal times.

#### **Observations:**

- The intersection of Wanless Drive and Edenbrook Hill is signalized with a posted speed limit of 60km/hr on Wanless Drive, and enhanced pavement markings. All signals and crosswalk buttons functioned properly. No school age children were observed crossing the intersection; however, school buses were observed in the vicinity.
- 2. There is an unfinished paved walking path 120 metres east of Edenbrook Hill heading towards Queen Mary Drive, this path continues on both sides of Wanless Drive.
- 3. The intersection of Wanless Drive and Queen Mary Drive is signalized with enhanced pavement markings and a speed limit of 60km/hr. All signals were operational during the site visit. A few students crossed the intersection, but most were accompanied by an adult.

#### **Recommendations:**

- 1. That the Site Inspection report for Rowntree Public School be received;
- 2. That the Manager of Transportation Right-of-Way & Safety be requested to arrange for the pedestrian signal timing to be reviewed prior to September 2024 to ensure it is adequate for school age pedestrians;

- 3. That Student Transportation of Peel Region and the school principal ensure that parents and students are advised that the walk to school routes are utilized at the two signalized intersections at Wanless Drive and Edenbrook Hill/Wanless Drive and Queen Mary Drive, and not the pathway on Wanless Drive that has no traffic control; and,
- 4. That a site inspection should be scheduled in September 2024 once students have returned to school and the crossings at the intersections have resumed.
