





#### **Observations:**

- 1. Sunny View Middle School is located on the east side of Chapparal Drive. The student population is currently 616 pupils. There are 3 small buses and 2 large buses that service the school.
- 2. Chapparal Drive has a posted speed of 40km/hr. There are "no stopping" signs posted on both sides of the road. Signs are located in the vicinity of the school.
- 3. During the afternoon inspection, many vehicles were seen parking on the East side of Chapparal Drive in the "No Stopping" zone as well as in the "No Parking" zone on the West side of Chapparal Drive. This created traffic congestion, which increased as students J-walked across Chapparal Drive to get to their vehicles.
- 4. Jaywalking was primarily observed between 2:30 p.m. and 3:00 p.m., coinciding with the school's dismissal period.
- 5. A huge number students were observed crossing the street without using designated crosswalks.
- 6. The traffic on Chapparal Drive was moderate to heavy during this time, with both vehicles and school buses passing by. The jaywalking increased the risk of accidents as students crossed unsafely between moving vehicles.

#### **Recommendations:**

- 1. That the Site Inspection report Sunny View Middle School, be received;
- 2. That the principal be requested to implement a safety awareness campaign within the school to educate students and parents about the dangers of jaywalking and the importance of using crosswalks; and,
- 3. That the Manager of Transportation Right-of-Way & Safety be requested to consider adding speed bumps or pedestrian signals in front of the school to slow traffic and improve safety which would prevent potential accidents.

#### **Observations:**

- 1. St. John Bosco Catholic School is located on the south side of North Park Drive. The student population is currently 259 pupils. The school is serviced by five small buses and two large buses.
- 2. North Park Drive has a posted "Flashing 40km/hr", during school hour arrival and dismissal times. Signage indicating "No Stopping, 8-5" are posted on both sides of the road leading up to and in front of the school.
- 3. The bus loading area is located on the right side of the school and the Kiss and Ride is at the front of the school. In the past years this was reversed, and the bus loading area was in front of the school.
- 4. During the site inspections, many drivers dropped/picked up students and or parked, leaving vehicles unattended in the bus loading zone. During the both inspection times, some parents used the limited parking spots, and some parents parked in or beside the school bus loading zone.
- 5. During the afternoon visit, many drivers who parked in parking spots or illegally parked in the fire route exited the school bus loading zone, travelling in the wrong direction. Several drivers waited in the "no stopping" zone on the school side of North Park Road.

#### Recommendations:

- 1. That the Site Inspection report for St. John Bosco Catholic School be received;
- 2. That the principal be requested to contact the School Board to review the Kiss and Ride and bus areas with the possibility of reverting to the original configuration on the property;
- 3. That the Manager of Enforcement and By-law Services arrange for the enforcement of the "No Stopping" restrictions on North Park Road during arrival and dismissal times.

#### **Observations:**

- 1. Ridgeview School is located on Brenda Avenue, south of Harold Street. Sign restrictions are posted on Brenda Avenue indicating No Parking/No Stopping. Corner restrictions signage are posted on the south side of Harold Street, west of the intersection. There is an enhanced pedestrian crosswalk line across the Brenda Avenue leg of the intersection.
- 2. During the morning site inspection, approximately 11 students crossed Brenda Avenue without any issues in the morning. In the afternoon, 12 students also crossed with no issues. There were sufficient gaps in the traffic flow for pedestrians to cross the roadway.
- 3. Vehicles were parked legally on Harold Street, west of the intersection, however they blocked the view of drivers exiting Brenda Avene. The corner restrictions should be moved further back for a clear site line.
- 4. In the evening, drivers stopped/parked on Brenda Avenue just south of Harold Street. This made it difficult for drivers trying to enter Brenda Avenue and for north bound drivers trying to exit Brenda Avenue. A bus driver entering Brenda Avenue was stuck and could not go around parked cars as there was no room.

#### Recommendations:

- 1. That the Site Inspection report for **Ridgeview Public School** be received;
- 2. That the Manger of Enforcement and By-law Services be requested to arrange for the enforcement of the No Parking/No Stopping restrictions on Brenda Avenue during syhool arrival and dismissal times;
- 3. That a Crossing Guard is not warranted at the intersection of Brenda Avenue and Harold Street; and,
- 4. That the Manager of Manager of Transportation Right-of-Way & Safety be requested to arrange for a site line review at Harold Street and Brenda Avenue for the drivers exiting Brenda Avenue and for parked vehicles on the south side of Harold Street, west of Brenda Avenue.

#### **Observations**

- 1. Burnt Elm Public School is located on the North side of Burnt Elm Drive, the student population is currently 807 students. Six large and five small school buses provide service to the school.
- 2. Burnt Elm Drive has a posted speed limit of 40km/hr. School Zone signs, and 'No Stopping' signs are positioned on the south side; and 'No Parking' signs are positioned on the east and west sides of the school driveway entrance into the school.
- 3. During the morning observation, several vehicles were observed parking in the 'No Parking' and 'No Stopping' zones. This obstructed traffic flow causing congestion at times. The school parking lot was blocked with pylons and two teachers removed them when the school buses arrived. School staff also crossed pedestrians across the Kiss and Ride entrance/exit as they commute from the sidewalk/street area to the school.

- 4. During the afternoon inspection, many vehicles parked on both sides of Burnt Elm Drive, in the 'No stopping' and 'No parking' zones, which caused a bit of congestion, narrowing street access for the larger buses accessing the school parking lot.
- 5. Jaywalking was observed between 2:30 p.m. and 3:00 p.m., coinciding with the school's dismissal period.

#### **Recommendations:**

- 1. That the site inspection report Burnt Elm Public School, be received;
- 2. That the Manager of Enforcement and By-law Services be requested to arrange for increased patrols during the school start and dismissal times to enforce parking regulations; and,
- 3. That the principal continue to educate the school community and students on safety procedures in and around the school at start and dismissal times.
