Trustee Davies, Peel District School Board, advised that the new school under construction and referenced as Mount Pleasant 9 Public School has been officially named as Red Cedar Public School.

Trustee Darryl D'Souza, Dufferin Peel Catholic District School Board, advised that a new elementary school with a capacity of approximately 465 pupils was scheduled to open in September 2025 at 320 Robert Parkinson Drive. The public will be consulted with respect to the naming of the school.

Trustee Davies, Peel District School Board, advised of a decline in the student population for the 2024-2025 school year.

Trustee D'Souza, Dufferin Peel Catholic District School Board, advised there was a significant decline in student population for the 2024-2025 school year.

10. Other/New Business

10.1 Update by Enforcement and By-law Services, re: School Patrol Statistics -October 22 - November 25, 2024

Committee commented that based on the statistics, more tickets should have been issued given the number of violations that they have witnessed during site inspections. Committee also inquired whether staff has seen a decrease or a downward trend at a particular school where tickets have been issued for noncompliance.

Kristie Anderson, Enforcement and By-law Services, advised that tickets are issued when required at the officers' discretion based on several factors. Education and compliance are also methods to achieve compliance, and this is done through conversations with residents and parents. Enforcement is in the process of hiring more staff, some of whom will be assigned to patrol the areas around schools to ensure compliance with parking and traffic signs. Staff will also review reports to provide some statistics on whether tickets are on a downward trend at schools where drivers have been ticketed for violations over a period of time.

Subject: Request for Crosswalk and Crossing Guard at Riseborough Drive and Oshawa Street

Dear Brampton School Traffic Safety Council,

I am writing to request the installation of a crosswalk and the assignment of a crossing guard at the intersection of Riseborough Drive and Oshawa Street, which is in close proximity to Sir Isaac Brock Public School. We have observed significant safety concerns during the morning drop-off period, particularly between 8:45 am and 9:00 am.

During this time, many students are crossing the street illegally, and numerous vehicles are either parking in the middle of the road or stopping in areas designated for no parking. Additionally, some families are not adhering to traffic laws, which has created dangerous conditions for both students and drivers.

To address these safety concerns, we have been compelled to close the back gate, forcing students to enter the school premises at the front. This also means that families must utilize the Kiss and Ride system or park in designated parking areas for safe drop-offs. However, despite these efforts, the unsafe traffic behavior persists, increasing the risk of accidents.

We believe that the addition of a crosswalk and a crossing guard at this intersection would significantly improve pedestrian safety and encourage safer behavior among drivers and families. Your attention to this matter is greatly appreciated, and we hope for a positive resolution.

We would like to inform you that we have consulted and collaborated with several key stakeholders in response to your request. These include:


- Trustee Satpaul Singh Johal

Good day,

The BSTSC is considering installing speed bumps or pedestrian crossing in front of Sunny View Middle School to improve safety.. The Automated Speed Enforcement camera has been installed on Chapparal Drive in front of the school and has been active since November 6, 2024. Traffic calming devices such as speed cushions are not installed in conjunction with ASE because their implementation would have negative impacts on this type of speed mitigating measure. Furthermore, installation of one category of speed mitigation measures allows for improved distribution of resources throughout the city. Based on the above, staff does not recommend installation of speed cushions along Chapparal Drive.

Traffic operations will conduct pedestrian crosswalk (PXO) study when weather permits and will share results to determine whether PXO is warranted or not.

Nature of Problem: Traffic safety concerns at Red Maple Drive and Royal Orchard Drive. Inquiry for crossing guard and traffic congestion.

Observers Present: Don Haberer, Citizen Member A.M., Julie Ellis, Team Lead, Crossing Guard, A.M./ P.M., Trustee Will Davies, P.M.

Observations:

- 1. Royal Orchard Middle School is located on the northwest side of Royal Orchard Drive. The student population is approximately 550 pupils. Eight large and small school buses and two special needs buses provide service to the school. Crossing Guards are not placed at middle schools.
- 2. There is a Kiss and Ride area on the property. The pavement markings in the Kiss and Ride area and the stop bar at the exit were faint.
- 3. Posted speed limit on Royal Orchard Drive is 40km/hr. Bicycle lanes are identified with pavement markings on both sides of Royal Orchard Drive. During the morning and afternoon visits, drivers stopped in the bike lanes to drop off/pick up children.
- 4. During the site inspections, drivers stopped in the bus drop-off/pick-up lane in front of the school and also parked in the visitor parking to drop off children.
- 5. More so during the afternoon visit, vehicles exited the school property at the intersection of Red Maple and Royal Orchard Drive and this caused significant delays. Drivers were aggressive leaving the school property and some pedestrians walking on the sidewalk had to stop for them. One driver headed north on Royal Orchard Drive had to brake hard to avoid a child crossing the north leg of the intersection. Drivers also created three exit lanes while exiting the parking lot, where there are only two lanes. Turning drivers had to wait for extended periods of time to let children cross Royal Orchard Drive.

Recommendations:

- 1. That the Site Inspection report for Royal Orchard Middle School, be received; and,
- 2. That the Principal be requested to:
 - Arrange for the Kiss and Ride pavement markings to be refreshed
 - Arrange for the stop bar to be repainted at the school exit and stop signs to be installed
 - Provide pedestrian safety education to the students
 - Provide safety reminder to drivers to yield to pedestrians
 - Suggest to parents that they not park in the bus drop area
 - Arrange for the school Planning department to review the exit from the school and possibly eliminate right turns.


- 1. Grenoble Public School is located on the west side of Greenbriar Road. The student population is currently 271 pupils. There is one small school bus, two large school buses and one special needs bus assigned to service the school.
- 2. Posted speed limit is 40km/h on Greenbriar Road. At the front of the school, signage is posted indicating "no stopping" on both sides of the road (8:00 A.M. to 5:00 P.M). There are also "no parking" signs posted on the east side Greenbriar Road.
- 3. Gondola Cresent intersects Greenbriar Road at two locations and does not have sidewalks at where it intersects with Greenbriar Road. During the morning, a total of five students crossed Greenbriar Road from those two intersections.
- 4. During the afternoon visit, approximately 10 students mostly accompanied by adults, crossed at the south intersection of Greenbriar Road. Four (4) students crossed Gondola Crescent and four students crossed at the north intersection of Greenbriar Road.
- 5. During the morning visit, some traffic congestion was created by a few vehicles as drivers attempted to exit the north side of the school property. Traffic flowed smoothly to exit the school property during the afternoon.
- 6. A makeshift Kiss and Ride operates in the narrow staff parking lot of the school, accessed from the north entrance to the school property. Some parents parked in the staff parking lot and other parents made U-turns and three point turns prior to dropping kids off in the parking lot. A few parents stopped in the parking lot aisle and walked their kids into the school.

Recommendations:

- 1. That the Site Inspection report for Grenoble Public School be received;
- 2. That the Principal of the school be requested to:
 - Ask the school Planning department to review the property to determine if a Kiss and Ride located on the northern most portion of the asphalt playground is feasible
 - Remind students to utilize the All Way Stop sign at the southerly intersection of Gondola Crescent and Greenbriar Road to cross the roadway
- 3. That a crossing guard is not warranted in front of Grenoble Public School as there were sufficient gaps in traffic and to cross without any pedestrian/vehicular conflicts.
- 4. That the Brampton School Traffic Safety Council conduct a follow up site inspection in the spring of 2025.

Observations:

- 1. The intersection of Major William Sharpe Drive and Gowland Gate is an All Way Stop with enhanced crosswalk markings on all four legs. There are sidewalks on both streets.
- 2. During the site inspections, compliance with the stop signs were observed at the intersection when pedestrians were utilizing the intersection. When there were no pedestrians, some drivers rolled through the crossing or stopped in the crosswalk.
- 3. During the site inspections, four students crossed Major William Sharpe Drive, and two students crossed Gowland Gate. There were no conflicts with traffic and there were lots of gaps in traffic to cross.

Recommendations:

- 1. That the Site Inspection report for Our Lady of Peace Catholic School be received; and,
- 2. That a crossing guard is not warranted at the intersection of William Sharpe Drive and Gowland Gate as there are sufficient gaps in traffic to cross.
