CITY OF BRAMPTON SNOW
CLEARING POLICY TO
ENCOURAGE WINTER CYCLING

Introduction

Consistent messaging is essential when trying to reform attitudes of the citizens of Brampton. When we say we want to encourage active transportation, all our policies should be on board with this end. That being said, if we are encouraging people to cycle year round, for transportation, we should make sure there is a welcome spot for their bikes at municipal destinations. This means bike racks should be cleared of snow, in a consistent basis, across the city.

Background

- In early December of 2019, while I was talking to a Brampton 311 staff person about an unrelated matter, I asked if 311 would be an appropriate place to request snow clearing around the bike racks of my local recreation centre. She put me on hold while she consulted with her supervisor about the matter. When we resumed our conversation, she informed me that her supervisor said that bike racks are considered to be not maintained during winter months.
- A few weeks later, I followed up on this with a written request on the 311 web page asking for this policy in writing as well as the name and contact information of the Brampton City manager who would be in charge of facilities maintenance.
- Within one week I received a phone call from a City of Brampton staff person who informed me she could arrange to have the bike rack area cleared of snow at Earnscliffe Recreation Centre, which was the recreation centre I patronize. I explained that I appreciated that but my original request still needed to be followed up.
- The same staff member contacted me in January of 2020, by phone, to confirm that the snow was being cleared satisfactorily from the bike rack at Earnscliffe Recreation Centre. I confirmed that it was, but that I was requesting that all municipal facilities be given the same consideration. She asked me for specific facilities. I told her I could not say specifically since I had not visited many of them after a snow fall. I reiterated my request for her to provide the contact information of the person who would be in charge of such things. She insinuated that it would be hard to do but she would try.
- On February 10th, 2020, I attended a meeting at Chris Gibson Recreation Centre. I noticed that the bike racks closest to the main door were socked in with snow. At this point I decided to follow this up with the Brampton Cycling Advisory Committee.






BIKE LANES



The City of Brampton is making it easier for cyclists to get around safely. Bicycle lanes are reserved for people on bikes and are typically marked by a solid white line and a bicycle symbol.

Here are some safety reminders:

Bicycle Lanes at Intersections

Bike Box



Certain intersections in Brampton have green "bike boxes," which allow cyclists to proceed ahead of vehicles at traffic signals.

Bike Lanes and Transit Stops



If you are driving a vehicle, you may sometimes need to enter or cross a bicycle lane to turn right at an intersection or driveway. Take extra care when you do this.

- For bike lanes that have a solid line extending to the intersection, vehicles are not allowed to enter the bike lane and drivers must yield to cyclists before they can complete their right turn.
- For bike lanes that have a dashed line leading to the intersection, drivers are allowed to enter the bike lane when it is safe and clear of cyclists.

Buses are allowed to stop in a bike lane briefly at transit stops. When riding in a bike lane approaching a stopped bus that is loading and/or unloading passengers, you must yield right-of-way to the bus. Do not attempt to pass the bus on its right hand side until it has completely cleared the bike lane.







Figure 4.65 – Two-Stage Left Turn Queue Box With Parking Lane Adjacent to Buffered Bicycle Lane





5. Committee Member and Sub-Committee Updates

BikeBrampton

Lisa Stokes, Member, and Stephen Laidlaw, Co-Chair, reported these updates from BikeBrampton:

- Webinar RE: Vodden/Howden Bike Lanes project update.

- A phase 1 re-opening compliant self-service mobile bike repair station, under the guidance of a certified mechanic, is being planned for setup on Etobicoke Creek Trail and Caledon Trailway in Town of Caledon;
- Caledon is approved; Brampton discussions ongoing.

Regional Councillor Santos acknowledged challenges of Brampton still being in phase 1 of re-opening. Reported recommending that staff work with park ambassadors to educate people on safe riding as well. Further recommended that the more we get the message out to people about safe riding behaviour, the better.

Laura Bowman, Member, suggested that there appears to be a divide in understanding of etiquette on the trails. In Toronto, ringing of a bell is sometimes met with hostility (though not yet seen in Brampton). People with different lived experiences will interpret etiquette signals (like ringing a bell) differently.

Dayle Laing, Member, indicated that in her observation, many people that cycle on the trails do not have bells. Has experienced people thanking her for using a bell. Education to a variety of experiences is required.

Barry Lavallee, Member, further elaborated on different responses to hearing a bell such as interpreting it as aggression. Suggested a future discussion RE: Line of sight issues from shrubs and tree branches on the path.

Regional Councillor Santos suggested installing signs to communicate challenging line of sight spots instead of cutting back trees.

6. Community Ride Updates (Cancelled for 2020)

Lisa Stokes, Member, indicated that Community Rides are cancelled up to the end of June. Still cautious about groups or with Community Rides in July.

Nelson Cadete, Project Manager, Active Transportation, Planning and Development Services, indicated that Community Rides are canceled for 2020.

Stephen Laidlaw, Co-Chair, suggested publishing routes online, with points of interest, that people can explore independently. Stephen indicated an interest in a subcommittee to bring back a proposal with further detail.

8.2 Discussion at the request of Dayle Laing, Member RE: East-West Vodden/Howden cycling corridor

Dayle Laing, Member, provided a report regarding participation in a May 28 webinar regarding the Vodden/Howden cycling corridor. Several members of BCAC in attendance.

Nelson Cadete, Project Manager, Active Transportation, Planning and Development Services, indicated that additional information to come. There is a slide deck, video recording and survey available online on the City of Brampton website.

8.3 Discussion request from Dayle Laing, Member RE: Williams Pkwy road widening from 4 to 6 lanes,

Dayle Laing, Member, provided a summary of the options that are being considered for the Williams Pkwy expansion. All 4 options align with the 2040 Vision to some degree.

- Option 1: Expand to 6 lanes, with curbside HOV lanes, with multi-use pathways. Mostly asphalt, few opportunities for adding trees. Qualifies for Development Charges funding most of the project. Staff recommended, but not unanimously.
- Option 2: 4 lanes with a larger buffer for landscaping.
- Option 3: 4 lanes, narrowed, with an increased buffer for landscaping.
- Option 4: Resurface only.

Regional Councillor Santos indicated bringing up issues with induced demand. Assumptions in the report did not include the effect of increased transit; the Risk of more cars increasing the risk of collisions.

Committee had a discussion on a strategy to contact local councillors, MPPs and MPs on the need to prioritize funding for active transportation such as changes to Development Charges funding formula. There was general agreement that this is an important case for future road widening projects.

Alina Grzejszczak, Member, expressed concern that the ongoing cost of maintaining a 6-lane road was not considered, and that traffic flow is taking precedence over safety for all.

Dayle Laing, Member submitted correspondence with these updates from BikeBrampton:

1. We are having a total of 10 BikeWrx pop-up cafés – 6 in Brampton and 4 in Caledon. At the first 4 events, we had 129 people sign in. One event in Caledon was shortened by thunder and rain. We have had licensed bike mechanics doing minor tune ups, installed over 75 Region of Peel bells, and lights, given out trail maps, and educated people on trail etiquette tips, especially on the proper use of the bell. We have had requests from both Brampton and Caledon Councillors to focus on lack of trail etiquette by speeding, non-bell-ringing cyclists on trails, so education is a primary goal for these events. We used both City of Brampton and Town of Caledon tents, as well as our own new branded tent for set up. We have a safety plan as per provincial guidelines, for proper COVID-19 sanitation. People have to use hand sanitizer before picking up the pen to sign in, and must wear masks to get service, or they stay a strict 2m away. Equipment is sanitized between clients. We have small construction cones to separate people 2m as they line up. The Duggan Park event had 58 people, which seemed steady and comfortable for the 2 mechanics and 3 staff volunteers over the two hours. Thanks to Nelson for the City tent loan, and more bells and trail maps. Upcoming pop-ups for [Brampton](#) and [Caledon](#) see links.
2. Pedalwise Protégés – 37 new protégés have signed up since the beginning of May! That is an astounding number that requires significant administration. We have lent out 22 bikes from the library in the same time period. Many have needed repair work to be ready for lending. There have been several donations and a few returns. We work by appointment only and people must wear masks, even in the parking garage at Sunny Meadow, where our bike cage is located.

3. Pedalwise Protégé and Mentor training - We have turned to physical distancing ZOOM calls for Pedalwise training of new and older protégés and mentors. Lisa and Dayle updated our slide deck, and Lisa has conducted almost 2 series of 4 hour-long sessions. There will likely be another round of 4 sessions. Attendance has ranged between 15 and 24 per session. Steve, Barry and Kevin have added comments to make the presentation very interactive, fun, informative and very valuable. Lisa and Alina conducted a Pedalwise Protégé Assessment Session for a group of 9 from the Brampton Northwest. The assessment is quite sophisticated and very helpful for new folks and those needing an interim evaluation. One lady could not take her hands off the handlebars to signal, so was avoiding road cycling. In the one short session, she successfully learned how to signal with confidence!
4. Anecdotally, we are seeing record numbers of cyclists on the roads and trails. Use of bells on the trails is way up from the past.

Steve Laidlaw: Snow removal:

Steve reported that he had made several attempts to have bike racks cleared of snow during winter months, at the City of Brampton recreation centres. He contacted 311, and did manage to have the rack at Earnscliffe Rec Centre cleared. He continues to work on the issue, after the COVID-19 shutdowns interrupted his communications with City staff.

Nelson's suggestion: ask City staff to create a policy of snow removal around municipal building bike racks, at the official meeting next month. Ask for a presentation at our meeting, if possible.

Lisa: question re sweeping of multi-use paths, standard of maintenance?

Nelson: at present, it is semi-annual, likely, though recommended by ATMP to increase, to bring it in line with street sweeping. Recommended: 2x/month, March-May, October-Nov, 1x/month other months – hasn't started yet, due to cost of equipment, etc.

During the discussion, it was mentioned also that construction workers should be held responsible to clean up after work.

Kevin mentioned that accessibility for mobility is an issue on multi-use paths, particularly around curb cuts, and should be addressed.

Nelson Cadete asked Steve to make a presentation during the December official meeting. Lisa Stokes offered to make contributions to the topic of clearing as well. Steve and Lisa will work on this for next month.

Polly Thornham: Committee of Council meeting Wednesday, November 18, 2020 Letter from BCAC on Williams Parkway Review, regarding the staff report.

Polly wrote a letter to the Committee of Council on behalf of BCAC, recommending option 3. She recorded a reading of the letter, as she was unable to attend in person, and submitted it as a delegation. Steve, Lisa and Dayle submitted delegations as well.

There was discussion regarding the likelihood of option 4 being chosen by the Committee of Council at the meeting. - 40 irreparable bikes dismantled for parts and scrap metal
- 18 sessions, with 133 participants, at the bike cage
- 10 Bikwrx pop-up cafes, 6 in Brampton, 4 in Caledon, with 300 participants

- focused on minor repairs and trail etiquette, as well as installation of 200 bells and lights
- City of Brampton lent a tent and new trail etiquette sign
- created cycling skills videos in English and Punjabi
- 58 new proteges, total increased, to 146 (68% > last yr.)
- held 8 1-hr. Zoom training sessions (2 series of 4), with 15-25 participants each
- younger demographic than last yr., with 62% < 35 yrs. old
- 50% in Canada < 5 yrs.
- working with TRCA on Ontario Active School Travel Program
- delivering way-finding program to 6 Peel Eco Schools
- presented to Camp Climate program and Catholic Cross-Cultural Services
- held a pilot outdoor training and assessment session
- participated in SmART Ride Contest with The Rose in November
- held a cycling challenge for proteges in October
