- Social media campaign includes short teaser videos (produced by Winged Whale Media) on all City platforms to coincide with the Mayor's announcement at Council on May 12th

   their web campaign will be launched on May 12th
- Advertisements will be posted in bus shelters the week of May 17th locations still to be determined
- Gift boxes will be ready and prepared for delivery to inductees when it is deemed to be safe
- Commemorative books have been updated with the new logo and will be sent to the print shop next week for inclusion in the gift boxes




## Site Plan






## **Ground Floor**

#### **Meeting Minutes:**

2 documents circulated prior to meeting for sub-committee review – Reference Projects and Architectural Recommendations

#### Floor Plan

- Matthew presented committee with floor plan of new building
- Creating additional parking
- Main entrance to SHOF is along the Victoria Cres side and will be accessible from main lobby
- Staircase to the 2<sup>nd</sup> floor (to access seating area of fieldhouse) will look into the SHOF
- Front of SHOF will be two stories, which will allow for taller displays, banners, etc.
- As you approach the facility there is a glass front where the SHOF logo can be displayed
- Direct access to MPR from SHOF
- An outdoor court yard is located north side of SHOF
- Two storage rooms within the SHOF area

#### Other Discussion Items

- Fire protection in the building in general and specific to the SHOF itself
- Interactive displays creating a fun interactive experience
- Protection of display artifacts and pictures from natural light (glazing, position of display cabinets, blinds all possible options)
- Sound management discussion around ceiling and flooring material
