5.1 Staff Presentations re: Sports Hall of Fame Committee Orientation

Charlotte Gravlev, Deputy Clerk, welcomed members of the Committee. At this time members introduced themselves and provided information regarding their experience and interest in the Committee.

Ms. Gravlev provided an overview of the procedural matters as they relate to the Sports Hall of Fame establishment and structure. The following was highlighted:

Teri Bommer, Coordinator, Sport Liaison, Recreation Services, provided background information on the Brampton Sports of Hall of Fame, highlighted the following:

Relocation of the hall to Victoria Park Arena

- Athletes inducted under four categories and current composition is at 213 members
- Governed by a Constitution approved by Council
- Six Sub-Committees are required to be selected with a chair for each one
- Attendance and participation are expected from members

Glenn McClelland, Co-Chair, acknowledged previous members, Dean McLeod and Ken Giles, who have retired from the Committee, as long standing members of the Sports Hall of Fame for several Terms of Council. #### 9. Building Update

9.1 Verbal update by Teri Bommer, Coordinator, Sport Liaison, Recreation Services, re: Building Update on the New Sports Hall of Fame

Teri Bommer, Coordinator, Sport Liaison, provide information on the new Sports Hall of Fame building as follows:

- Work was continuing with the curatorial consultants and the interpretative planner on the design of the space
  - intent was to open the entire facility at the same time
- RFP (Request for Proposal) for the hiring of a contractor will be sent out soon and the earliest completion was anticipated at this point was fall of 2025
- Requirement for a Building Sub-Committee to be established at the October meeting
  - meeting will be arranged with the Building Sub-Committee and an update provided on the status of the design of building
  - sub-committee role would be to report to the Sports Hall of Fame Committee meetings

Ms. Bommer advised that she received three items as donations for the Sports Hall of Fame, a signed hockey stick, a signed Team Canada jersey and an original shirt worn by the individual who dropped the hockey puck at a game. Ms. Bommer requested Committee's direction on whether these items should be accepted as memorabilia, since there is no collection policy with respect to donations made to the Sports Hall of Fame.

There was discussion regarding the need for a collection policy. Ms. Bommer advised that a draft collection policy was currently being reviewed for input by Peel Art Gallery and Museum Archives (PAMA) and will be presented to this Committee for review and input at a future meeting.
