It has come to my attention that the proposed, original plan to build a three-story extension attached to Peel Memorial Hospital has been revised to build a thirteen story extension.

I am emailing you as a resident of [REDACTED] and expressing my displeasure at the revision for numerous reasons. They are as follows:

- 13 stories would compromise my privacy, as I am currently unable to afford any shutters or blinds
- Patient privacy would be compromised
- The size of the building and it's location doesn't fit PMH's current structure
- I am a first responder and have been so for years. I require the natural unobstructed sunlight to maintain normal sleeping schedules, particularly as I work day and night shifts cycles, waking as early as 4am and coming home as late as 9am some days

I fully support the expansion; as an emergency first responder I deal with hospitals on a weekly basis, however, I am hoping there can be a compromise reached in regards to the size of the building.

I immigrated to Canada in the 90s, I have never taken any handouts and I saved my whole life to purchase my home. All I ask is for some consideration for your constituents whom would be affected by such a large expansion.
