11.1 Larkspur Public School, 111 Larkspur Road, Brampton

Committee reviewed the observations and recommendations in the site inspection report.

In response to a question on the use of the Kiss and Ride at arrival and dismissal times, Traffic Services and Enforcement and By-law Services staff provided information on their observations of the operations during those hours. Staff advised that schools generally permit students being dropped off in the Kiss and Ride route, noting that this activity has resulted in traffic congestion and safety issues from time to time. Staff referenced the recommendations in the site inspection report which requested the school principal to review this matter with the school board.
