## **OVERVIEW:**

- This report is staff's response to CW020-2024. A delegation from Jackie Duffus, Brampton resident, to the Committee of Council Meeting of January 31, 2024, re: Ceremonial Street Naming Maudlyn Biso.
- Ceremonial Street naming's do not apply to legal street namings or renamings.
- This report asks the Committee of Council to either approve or deny this request as all ceremonial street namings are approved at the discretion of Council.

### **BACKGROUND:**

CW020-2024 That the delegation from Jackie Duffus, Brampton resident, to the Committee of Council Meeting of January 31, 2024, re: Ceremonial Street Naming - Maudlyn Biso, be referred to staff for consideration.

The delegation requested Murray Street (between Horsham and Gillingham) to be ceremonially named as Maudlyn Way. In honour of Maudlyn Biso who silently served her community and resided at 269 Murray Street for over 30 years until her passing in January 2023.

#### **CURRENT SITUATION:**

As ceremonial street naming's are approved at the discretion of Council, staff are referring the matter back to Council along with the Standard Operating Procedure for these decisions and are requesting Council to either approve or deny the request.

If the request is not approved, no further action is required.

If Council approves the request, the staff will begin the planning process.
