- Formed in 2018 as an output of Medical Alley Strategy Pivot
- By the numbers:
 - Approaching \$1 billion of deal volume (investment, M&A)
 - Served 900 startups in 2022, targeting 1200 in 2023
 - 60% of companies were ex-Minnesota in 2022, expect 75%+ ex-Minnesota in 2023
- Collaborations with top organizations including NEA, Andreessen Horowitz, Medtronic, Bayer, CVS Aetna, and more

Better global market access and global innovation.

Sourcing global investment into Medical Alley while opening new global market opportunity.

- Help OUS firms establish US base and partnerships to drive deal flow into Medical Alley partners

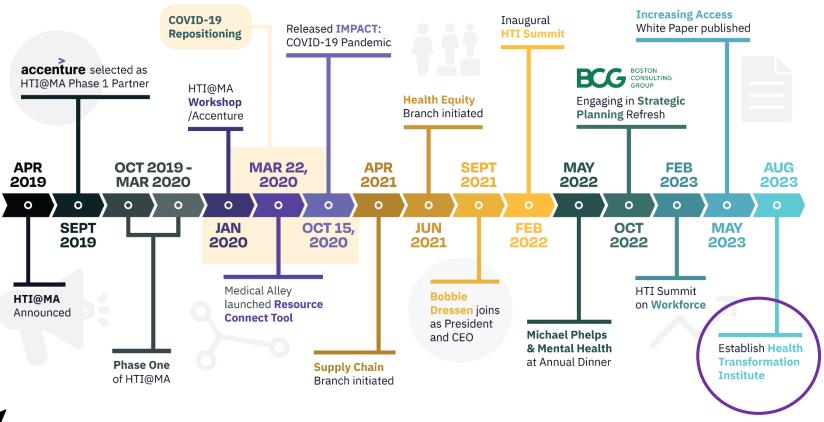
Understand and influence your customer/partners and adapt to new business models to sustain/accelerate growth.

- While associations focus on stopping bad policy or protecting narrow interests of a sector,

- Examples include crafting language for the MOMS Act to expand maternal healthcare, advising governments in Canada, Australia, and the Netherlands on Innovation Policy, and consulting with the IFC, a division of the World Bank, on health development policy on the African continent.
