Ontario Helping Seniors Stay Fit, Healthy and Active

- The Ontario government is investing up to \$15M to support all current Seniors Active Living Centres (SALC) programs across the province which connects seniors with resources and activities.
- A majority of SALC programs will receive funding of up to \$50,000 to deliver a variety of programs.
- A call for proposals for organizations to deliver SALC programming will be opening this summer.
 - In addition to municipalities, other local and community-based organizations such as Legions, Lion's Clubs, and other social and recreational clubs are eligible to apply.

The City of Brampton applied for this funding for three locations that offer a significant amount of senior programming (Bob Callahan Flower City Seniors Centre, Knightsbridge Seniors Centre, and Riverstone Community Centre) and were approved for up to \$50,000 of funding for each location.

Connecting Youth in Peel Region to Mental Health Services


- The province is launching a new Youth Wellness Hub in Brampton to serve Peel Region.
 The hub will open in 2025 and connect youth aged 12 to 25 and their families across Peel to free mental health, substance use and primary care services.
- Other services provided through the hub will deliver culturally appropriate care, including:
 - Vocational supports
 - Education
 - Employment
 - Housing
 - Access to community programs
 - Support for children and youth in need of child welfare services while in care or transitioning out of care

The City welcomes the launch of the new Youth Wellness Hub in Brampton, as it will help address the growing need for youth mental health supports in the region. The City continues to advocate for adequate funding and supports for youth in Brampton, including through the upcoming AMO Conference in Ottawa.

Canada's 2030 Nature Strategy

- The Minister of Environment and Climate Change, announced the release of Canada's 2030 Nature Strategy and introduced an Act respecting transparency and accountability in relation to certain commitments Canada has made under the Convention on Biological Diversity (Nature Accountability Bill).
- The 2030 Nature Strategy lays out how Canada will implement the ambitious nature protection goals under the Kunming-Montréal Global Biodiversity Framework that were agreed upon at the COP 15.

Canada's 2030 Nature Strategy supports and aligns with the intent of several City strategies, projects and Term of Council Priorities.

Government of Canada Announces Deployment of X-Ray **Scanners to Combat Auto-Theft**

- The federal government announced the deployment of a mobile X-ray scanner to the Greater Toronto Area (GTA) which will increase the examination of containers in Ontario.
 - The addition of this scanner in the GTA will provide border services officers with an additional tool to detect stolen vehicles
- This is one of the initiatives being undertaken as part of the National Action Plan Combatting Auto Theft, which focuses on disrupting, dismantling, and prosecuting the organized criminal groups behind auto theft.

The City of Brampton welcomes this announcement as it has been at the forefront with its advocacy for enhanced actions to combat auto theft, including collaboration with all levels of government and stakeholders.
