## BY-LAW Number \_\_\_\_\_- 2023

To amend Comprehensive Zoning By-law 270-2004, as amended
---

The Council of the Corporation of the City of Brampton, in accordance with the provisions of the *Planning Act, R.S.O. 1990, c.P. 13,* hereby ENACTS as follows:

- 1. By-law 270-2004, as amended, is hereby further amended:
