This project raises serious concerns about its potential impact on the community's infrastructure, environment, and overall quality of life.

1. Inadequate Infrastructure

Where are the public Libraries?

What about the community centers? how many medical facilities are scheduled or available?

We respectfully ask the city to reconsider this project or make substantial modifications to better align with the existing character of our community. Development should be thoughtful, taking into account the need for proper infrastructure, public services, and green spaces. As it stands, this project will create more challenges than benefits for our neighborhood.

We are open to development that enhances our community, but this proposal, in its current form, does not. We hope you will take our concerns seriously and seek a more balanced and sustainable alternative.
