Terms & Conditions for Exhibitors & Attendees of "Lifestyle Expo Business & Investors Conference 2025" Canada

1. Definitions

- **Exhibitor:** Any company, organization, or individual who has contracted to display products or services at the Lifestyle Expo Business & Investors Conference 2025.
- **Attendee:** Any individual who has registered to attend the Lifestyle Expo Business & Investors Conference 2025.
- **Organizer:** World Trade Developers Inc., the entity responsible for organizing the Lifestyle Expo Business & Investors Conference 2025.
- **Event:** The Lifestyle Expo Business & Investors Conference 2025 held at Brampton, Ontario, Canada, on June 20,21,22, 2025.

2. Registration and Payment

- **Exhibitors:** Must complete the exhibitor application form and submit it along with the required payment by the specified deadline. Booth space is assigned on a first-come, first-served basis.
- **Attendees:** Must register and pay the applicable fee by 30th March 2025. Registration is confirmed upon receipt of payment.

3. Cancellation and Refund Policy

- **Exhibitors:** Cancellations received before April 1, 2025, will receive a 50% refund. No refunds will be issued for cancellations received after this date.
- **Attendees:** Cancellations received before May 1, 2025, will receive a 50% refund. No refunds will be issued for cancellations received after this date.

NOTE: In case of visa rejection 100% amount will be refunded back within 60 days, after deduction of bank charges & tax.

4. Booth Setup and Dismantling

- **Setup:** Exhibitors may set up their booths on June 19, 2025, from 10:00 AM to 6:00 PM. All booths must be fully operational by 10:00 AM on June 20, 2025.
- **Dismantling:** Exhibitors must dismantle their booths between 6:30 PM and 10:00 PM on June 22, 2025. Early dismantling is not permitted.

5. Booth Operation

- Exhibitors must ensure their booths are staffed during all event hours.
- Exhibitors are responsible for maintaining the cleanliness and safety of their booth space.
- No disruptive activities, including loud noises or flashing lights, are allowed.

6. Liability and Insurance

- The Organizer is not liable for any loss, damage, or theft of property. Exhibitors and attendees are responsible for securing their own insurance coverage.
- Exhibitors are responsible for any damage caused to the event venue by their booth setup or activities.
