I am writing to notify you that on September 13, 2024, I granted the City of Brampton's request for a Minister's Zoning Order on the lands at 545 Steeles Avenue West in the City of Brampton.

Ontario Regulation 357/24 facilitates development of a mixed-use community with approximately 1,277 residential units (including student housing) on the subject lands.

Our government values the unique role and contributions of Indigenous communities in land use planning and development, and we welcome their perspectives and traditional knowledge as part of an ongoing discussion with our municipal partners to support Ontario's sustainable and responsible growth. I expect the City of Brampton to engage with Indigenous communities through the development approvals process at the municipal level in relation to 545 Steeles Avenue West.
