





#### **COMPONENTS of a BRAMPTON TAX BILL**




#### ALLOCATION of TAXES by SERVICES


#### **2025 CAPITAL BUDGET**

- Other Funding 7.1%


#### 2025-2029 CAPITAL BUDGET
