# BY-LAW

**To amend the Schedule of Traffic By-law 93-93, relating to NO PARKING  
(Schedule XIV)**

---

WHEREAS the Council for The Corporation of the City of Brampton has adopted and the Traffic and Parking By-law No. 93-93, (“By-law 93-93”) as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001*, a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending NO Parking (Schedule XIV):

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule XIV:

**NO PARKING**

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
James Potter Road	East	A point 115 metres south of Williams Parkway and a point 50 metres north of Roundstone Drive	Anytime except Fridays 11:00 am – 3:00 p.m.
James Potter Road	East	Bovaird Drive West and a point 115 metres south of Williams Parkway	Anytime

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XIV:

**NO PARKING**

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
James Potter Road	North/East	A point 115 metres east of Williams Parkway and a point 50 metres west of Roundstone Drive	Anytime except Fridays 11:00 am – 3:00 p.m. and 8:00 p.m. – 11:30 p.m.
James Potter Road	East	A point 60 metres south of Roundstone Drive and a point 60 metres north of Valleyway Drive	Anytime except Fridays 11:00 am – 3:00 p.m. and 8:00 p.m. – 11:30 p.m.
James Potter Road	East	A point 60 metres north of Valleyway Drive and Steeles Avenue West	Anytime
James Potter Road	North/East	A point 60 metres south of Roundstone Drive and a point 50 metres north of Roundstone Drive	Anytime
