WHEREAS By-law 218-2019, Administrative Penalties (Non-parking) By-law, was enacted on September 25, 2019;

AND WHEREAS Council for The Corporation of the City of Brampton is desirous of amending By-law 218-2019;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 218-2019 is hereby amended by:

Replacing number in reference to By-law 332-2013 with reference to current By-law 184-2023 in four areas:

- a. On page 4, Part V- Service of Penalty Notice, section 10(2), replace reference in the sections from By-law 332-2013 to By-law 184-2023 and from Mobile Licensing By-law 67-2014 to By-law 101-2025
- b. On page 13, replace number in header Business Licensing By-law 332-2013 with Business Licensing By-law 184-2023
- c. On page 13, section 3(a) change number from By-law 332-2013 to By-law 184-2023
- d. On page 17, the heading of Mobile Licensing By-law number to be changed from 67-2014 to 101-2025, and section 6(a) the By-law number be amended from 67-2014 to 101-2025

2. For the purpose of section 3 of this By-law these items are to be added under the Administrative Penalties (Non-parking) By-law listed in Schedule "A" chart – Mobile Licensing By-law:

(a) Column 1 in the following table lists the provisions in the Mobile Licensing By-law 101-2025 that are hereby designated for the purposes of section 434.1 of the Municipal Act, 2001;

(b) Column 2 in the following table sets out the short form wording to be used in a Penalty Notice for the contravention of the designated provisions listed in Column 1;

(c) Column 3 in the following table sets out the Administrative Penalty amounts that are payable for contraventions of the designated provisions listed in Column 1.

| 4 | Schedule 4 Part XXX - Prohibitions section 59,60,61 or 62 | Fail to comply with a provision of this By-law or an order of an officer as listed in Schedule 4 | \$250 |
| 5 | Schedule 5 Part VII - Prohibitions section 40 or 41 | Fail to comply with a provision of this By-law or an order of an officer as listed in Schedule 5 | \$250 |
| 6 | Schedule 6 Part III – Prohibitions section 9,10 or 11 | Fail to comply with a provision of this By-law or an order of an officer as listed in Schedule 6 | \$250 |
