To amend Business Licensing By-law 184-2023, as amended.

WHEREAS By-law 184-2023, provides for a system for licensing Stationary Businesses;

AND WHEREAS Resolution C003-2026-2026 (CW017-2026) passed by Council on January 21, 2026 to approve the licensing of Wildlife Removal Businesses and Housekeeping Amendments to Business Licensing By-law 184-2023;

AND WHEREAS Subsection 11(3) of the *Municipal Act, 2001* provides that a municipality may pass by-laws respecting: in paragraph 9, Animals, and in paragraph 11, Business Licensing;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That Business Licensing By-law 184-2023, as amended is hereby further amended by adding Schedule 28 – Wildlife Removal, attached as Schedule “1” to this By-law.
2. That Business Licensing By-law 184-2023, as amended, is further amended by adding and inserting Schedule 28 licensing fee and expiry date after Schedule 27 and before Schedule 29 to Appendix A, Fee Schedule, relating to Wildlife Removal, as follows:

3. That Business Licensing By-law 184-2023, as amended, is hereby further amended by adding Schedule 29 - Doggie Daycares, attached as Schedule “2” to this By-law.
4. That Business Licensing By-law 184-2023, as amended, is hereby further amended by adding and inserting Schedule 29 licensing fee and expiry date after Schedule 28 to Appendix A, Fee Schedule, relating to Doggie Daycare Businesses, as follows:

8. That Schedule 10 of Business Licensing By-law 184-2023, as amended, is deleted and replaced by Schedule “6”, attached hereto this by-law;
9. That Schedule 17, Appendix 1 of Business Licensing By-law 184-2023, as amended, is deleted and replaced by Schedule “7”, attached hereto this by-law;
10. The Schedule 20 of Business Licensing By-law 184-2023, as amended, is deleted and replaced by Schedule “9”, attached hereto this by-law;
11. That Part VI section 11 of Business Licensing By-law 184-2023, as amended, be further amended by adding and inserting after (f) the following:

“(g) A letter of approval issued by Animal Services indicating an inspection has been completed and all compliances have been met.”
