## **Summary of Transcript**

### Background

Regional Councillor Medeiros provided information to Committee regarding recent events that occurred in Sri Lanka, whereby a Tamil memorial monument was destroyed at a university. Councillor Medeiros advised that Members of the Brampton Tamil community have expressed an interest in erecting a monument in Brampton, in dedication to the contributions of the Tamil community.

### The Motion: CW041-2021

Whereas The City of Brampton is home to a diverse population deserving of recognition; and Whereas according to the 2016 census, Brampton is home to more than 4660 Tamils; and Whereas Brampton's Tamil community has made significant contributions to the City of Brampton's growth in the areas of business, arts, and culture; and Whereas by constructing a monument, the City of Brampton recognizes the contributions of the Tamil community and celebrates its rich culture; Therefore Be It Resolved that The City of Brampton work with the Brampton Tamil Seniors Association and the Brampton Tamil Association to locate a city park or facility to construct a monument; and 36 That staff also investigate potential funding contributions from federal and provincial government sources.

# Speech and the presentation

Good morning His worship Mayor Patrick Brown and the members of the Council. I thank you for the opportunity to speak to you today.

My name is Sena Munasinghe, I'm the President of Sri Lanka Canada Association of Brampton. We are a community organization for Bramptonians with Sri Lankan origin. I'm here to voice the Sri Lankan communities' concern about the motion passed by this Council to support the erecting of a monument to recognize the contributions made by the Sri Lankan Tamil community to Brampton. The motion passed seems great. Unfortunately, the media publicity given to that decision speaks otherwise, which is in stark contrast to the Brampton 2040 vision of living the mosaic. Therefore, we are compelled to speak up to ensure that our elected representatives do not go against the long-term vision of the city.
