To establish certain lands as part of the public highway system (Personna Circle, Williams Parkway, Valleyway Drive, Degrassi Cove Circle, James Potter Road, Crystalglen Crescent, Owlridge Drive, Fandango Drive and Iverson Drive)

WHEREAS it is deemed expedient to establish certain lands as part of the public highway system.

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The lands acquired by The Corporation of the City of Brampton and described as Reserve Blocks 651, 652, 653, 654, 665 and 666 on Plan 43M-1717 are hereby established as part of the public highway system to be part of Personna Circle.
2. The lands acquired by The Corporation of the City of Brampton and described as Reserve Blocks 658 and 664 on Plan 43M-1717 are hereby established as part of the public highway system to be part of Williams Parkway.
3. The lands acquired by The Corporation of the City of Brampton and described as Reserve Blocks 663 and 667 on Plan 43M-1717 are hereby established as part of the public highway system to be part of Valleyway Drive.
4. The lands acquired by The Corporation of the City of Brampton and described as Reserve Blocks 662, 669 and 673 on Plan 43M-1717 are hereby established as part of the public highway system to be part of Degrassi Cove Circle.
5. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 660 on Plan 43M-1717 is hereby established as part of the public highway system to be part of James Potter Road.
6. The lands acquired by The Corporation of the City of Brampton and described as Reserve Blocks 659 and 670 on Plan 43M-1717 are hereby established as part of the public highway system to be part of Crystalglen Crescent.
7. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 655 on Plan 43M-1717 is hereby established as part of the public highway system to be part of Owlridge Drive.
8. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 657 on Plan 43M-1717 is hereby established as part of the public highway system to be part of Fandango Drive.

9. The lands acquired by The Corporation of the City of Brampton and described as Reserve Block 656 on Plan 43M-1717 is hereby established as part of the public highway system to be part of Iverson Drive.
