Item 5.1 Peel 2051 Regional Official Plan Review and Municipal Comprehensive Review (Staff Presentation)

Overview:

- Peel 2051 is update the Regional Official Plan to conform to Provincial plans, policies and legislation and address Regional needs
- Address allocation of growth to 2051, review Regional Structure, identify Strategic Growth Areas and Employment Areas, Settlement Area Boundary Expansion and identify Agricultural, Rural and Natural Heritage Systems
- Over 60 engagement events including informal in person and virtual open houses, pop up events, and open houses

<u>City of Brampton Staff Comments (Planning & Public Affairs)</u>:

- Statutory Public Meeting is required as part of the Official Plan Review and Municipal Comprehensive Review (MCR) and conducted in accordance with the Planning Act
- City staff consistently point out that population growth is being underestimated in Brampton
- Population projection to 2051 on slide is too low and that Brampton projection number of 1.1M is more realistic.
- As of Monday November 11, 2021 there were 4 oral and 17 written submissions received as part of the public meeting agenda



Provincial Government Update



October 29, 2021: A memorial service to celebrate the Hon. Premier William G. Davis, will be held at Roy Thomson Hall at 11:00 a.m. on November 4, 2021.

- Members of the public can reserve tickets through Roy Thomson Hall web site.
- Livestream to be available on the Government of Ontario YouTube channel.

October 29, 2021: Investing app. \$72M/2 years to address the backlog of criminal cases that have accumulated in the justice system as a result of the pandemic.

October 29, 2021: Announced more than \$36M in community-led mental health and addictions supports in Indigenous communities across the province.

October 28, 2021: Announced increased access to low-barrier testing options to support in-person student attendance at school and reduce disruptions to families.

October 28, 2021: Investing additional \$373M to extend the temporary wage enhancement for personal support workers and direct support workers.

On Oct. 27, 2021 the government announced up to \$100M to add an additional 2,000 nurses to the long-term care sector by 2024-25.

IVERNMENT Lations

October 29, 2021: Provided further details on new vaccine requirements. As of 3 AM (EDT) October 30, 2021 the vaccination requirements will apply to all travelers 12 years of age plus four months who are:



- Air passengers flying on domestic, trans-border, or international flights departing from certain airports in Canada; and
- Rail passengers on VIA Rail and Rocky Mountaineer trains.
- Travelers will need to show airlines and railways proof of vaccination. For a short transition period until November 29, 2021, travelers have the option to show proof of a valid COVID-19 molecular test in order to board.
- As of November 30, a negative COVID-19 molecular test will no longer be accepted as an alternative to vaccination.
