4. Previous Minutes

4.1 Minutes - Environment Advisory Committee - August 10, 2021

5. Presentations\Delegations

5.1 Presentation by Pam Cooper, Environmental Planner, Public Works and Engineering, and Shannon Malloy, Specialist, Integrated Water Management, Credit Valley Conservation, re: Fletchers Creek SNAP: Glendale Rain Garden and Haggert Avenue Bioswale

Pam Cooper, Environmental Planner, Public Works and Engineering, and Shannon Malloy, Specialist, Integrated Water Management, Credit Valley Conservation, provided a presentation regarding the Fletchers Creek SNAP: Glendale Rain Garden and Haggert Avenue Bioswale.

Committee discussion on this matter included the following:

- Questions regarding the bioswales and water that enters the underdrain pipe
- Litter along the Fletchers Creek trail system and the need to organize a clean up of this area
- Questions regarding the impact of the bioswale on improving habitat for fish and plants
- Information on the type of monitoring taking place for this system and clarification on why there is no in-stream monitoring
- Indication from staff that there is extensive data available that demonstrates bioswales are effective

5.2 Presentation by Michael Hoy, Supervisor, Environmental Planning, Public Works and Engineering, re: Centre for Community Energy Transformation

Michael Hoy, Supervisor, Environmental Planning, Public Works and Engineering, provided a presentation regarding the Centre for Community Energy Transformation, and sought Committee's support for its formation.

Committee discussion on this matter included the following:

- Expression of thanks to staff for their efforts in relation to this program and in helping the City achieve its targets
- Clarification from staff regarding the focus of the CCET, which includes home energy efficiency (retrofits) and district energy nodes

- The importance of a comprehensive home retrofit program to meet environmental targets
- Information from staff regarding retrofit programs available for industrial and commercial sectors, to reduce energy and emissions
- Impact of natural gas on CO2 emissions, the need to encourage gas
 providers to move towards a more renewable or cleaner form of natural gas,
 and the positive impact of the CCET in this regard
 - o It was noted that over 80 per cent of homes are heated by natural gas
- Encouraging developers to consider alternative energy options for new residential developments
- Information from staff regarding sustainable thresholds for residential development applications
 - Staff advised the sustainable thresholds are being updated and incentives for achieving targets are being considered
- Indication that the new Heritage Heights Secondary Plan is aiming to be a near-net-zero community

Committee expressed support for staff's request to have representatives from the Environment Advisory Committee delegate Council in support of the CCET when the staff report is presented.

6.1 Verbal Update from David Laing, Chair, Grow Green Network Sub-committee, re: Brampton Environmental Alliance

David Laing, Chair, Grow Green Network Sub-committee, provided an update on the Brampton Environmental Alliance (BEA), which included the following:

- BEA meeting attendance and virtual meeting platform
- BEA strategic plan and vision for Brampton to be a sustainable community that is healthy and resilient economically, environmentally and socially
- The strategy is based on one planet living with four focus areas: networking, advocacy, events, and education and resources
- Partnership with the City of Brampton on Earth Day events and activities
- Advocacy work with the City of Brampton to support and expand initiatives to combat global warming (e.g. greening of the City's fleet and facilities)
- BEA membership, including how to apply and the term of membership

Kristina Dokoska, Policy Planner, Environment, Public Works and Engineering, provided an update on the Grow Green Awards, which will take place on Earth Day. Ms. Dokoska provided information on the following:

- Various types of awards

- Role of the Award Coordinators, and a request for volunteers from this committee to fill these roles
- Timelines for nomination forms

- Information regarding the Residential Tree Planting Program (e.g. number of registrations, public engagement and education), and possible modifications to the program

Zoe Milligan, Environment Project Specialist, Public Works and Engineering, provided an update regarding the Natural Heritage System (NHS) Survey. She advised that the purpose of this survey is to collect information from residents to gage the level of understanding on the natural heritage system and to learn how the public uses these spaces. Ms. Milligan provided information on the number and distribution of participants to date, noting that additional focus will be placed on reaching youth and residents in other key areas with low engagement. In

addition, Ms. Milligan thanked Committee members for their efforts in promoting this survey, and requested that members continue these efforts and send the survey link to their networks.

6.5 Verbal Update from Stavroula Kassaris, Policy Planner, Environment, Public Works and Engineering, re: Sustainable Fleet Strategy

Stavroula Kassaris, Policy Planner, Environment, Public Works and Engineering, provided an update on the City's Sustainable Fleet Strategy. She advised that the majority of the corporation's GHG emissions is due to the City's fleet, and indicated that the focus of this strategy is to reduce corporate emissions by right-sizing and reducing the existing fleet without impacting service. Ms. Kassaris provided additional information regarding life-cycle assessments and electrification of vehicles, and advised that the strategy is near completion and is expected to be presented to Council before year-end. Ms. Kassaris added that the City of Brampton is considered a leader in fleet sustainability.

Stacey Wilson, Committee Member, provided information to Committee on the concerns raised during the Environment Advisory Committee delegation to the

Committee of Council on September 8, 2021, regarding tree planting and maintenance. She advised that the City's Forestry Division has a significantly smaller staff complement than the cities of Mississauga and Toronto, which impacts staff's ability to maintain, monitor and inspect the City's trees. In addition, Ms. Wilson provided information on contractor responsibilities to replace new trees that do not survive, and highlighted the need for additional staff to inspect these trees and ensure they are replaced in a timely manner.

In response to a question from Committee, Michael Hoy, Supervisor, Environmental Planning, Public Works and Engineering, advised that Forestry staff will provide a presentation regarding this issue at the next Committee meeting on December 7, 2021.

Discussion on this matter included a suggestion for Committee to explore options to educate the public about the importance of maintaining trees on the boulevard adjacent to their homes.
