- Accessibility For Life Training 80 per cent of staff completed the training program

- Award Ceremony to recognize the commitment to accessibility and inclusion of people with disabilities
- Continue to review and provide comments on site plans and capital projects
- Next steps and goals:

- AODA requirement on the number of persons with disabilities on the Committee – the AAC currently does not appear to meet the requirement
