I am Counsel for the Region on Halton. I am writing on behalf of the Region of Halton to express concerns with the above noted report (the ICBL report) being considered by the City's Planning and Development Committee this evening.

This is of interest to the Region and the Town of Halton Hills given that they are both signatories to the HPBATS MOU. The Region understands that the Town of Halton Hills has already expressed concerns that the action proposed in the ICBL report does not address how the actions being proposed address the MOU. That is, the ICBL report is silent as to how the City will continue to ensure that other components of the HPBATS MOU remain protected as they integrate into the GTA West Corridor.

As Mr. Wilker noted this concern is of great importance to both the Region and the Town.

The Region would appreciate it if you would advise Planning and Development Committee of these concerns.
