8.1 Update by Teri Bommer, Coordinator, Sport Liaison, Community Services, re: 2022 Induction Event

Teri Bommer, Coordinator, Sport Liaison, Community Services, referenced the minutes of the Event Sub-Committee meeting of February 24, 2022 noting that only one member of the Committee was in attendance.

She provided an overview of the decisions made at the meeting as outlined in the minutes and requested input from members on entertainment, including the singing of O'Canada, decor and color scheme, catering, honour guard and piper, and the various Committee responsibilities.

Committee discussion followed and included the following:

- Suggestions for entertainment members will email staff with information for consideration of high school students, and Carmen Spada, professional jazz player
- Decor preference was for flowers at the event, no balloons

- Support to maintain the Honour Guard and Piper tradition
- Agreement by Members to reach out to inductees directly prior to standard letter/email being sent to them
 - Ms. Bommer will provide information to members to note in communication with the inductees
- Awaiting quotes from videographer for six inductee videos for use on social media
- Support for Ken Reid to deliver keynote address
- Meeting scheduled with Strategic Communications on March 4, 2022 regarding the media release of the inductees
- Awards to inductees will feature the new Sports Hall of Fame logo instead of the plaques
- Draft of the biographies will be forwarded to inductees for review
- Emcee Pat Boland will host the event
- Script of 2019 is being reviewed and updated for current event

Ms. Bommer suggested that during the induction ceremony, the Class of 2021 should also be recognized by displaying their videos on the Rose Theatre lobby screens during dinner, with a brief acknowledgement of the inductees.

Ms. Bommer also suggested that following the 2022 event, members should meet to discuss ways to improve, modernize and refresh the event for next year.

Ms. Bommer responded to comments and questions regarding the installation of biographies and photos at the CAA Centre noting that the focus will be on the Class of 2021. Discussions will follow with Ron Howard, Curator, with respect to timelines and placement of material for the Class of 2022. Comments were noted with respect to the use of the half-walls as an option.
