To amend the Schedule of Traffic By-law 93-93, relating to Yield Signs (Schedule V), Handicapped Loading Zones (Schedule XXI) and Prohibited Pedestrian Crossings (Schedule XXXVI)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, (“By-law 93-93”) as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act 2001*, a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending YIELD SIGNS (Schedule V), Handicapped Loading Zones (Schedule XXI) and Prohibited Pedestrian Crossings (Schedule XXXVI);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following item from Schedule V:

YIELD SIGNS

COLUMN 1 INTERSECTION OR LOCATION	COLUMN 2 FACING TRAFFIC
Elderwood Place and Elderwood Place	Southbound on Elderwood Place

2. By-law 93-93 as amended, is hereby further amended by ADDING the following item to Schedule XXI:

HANDICAPPED LOADING ZONES

COLUMN 1 INTERSECTION OR LOCATION	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 DAYS OR TIMES	COLUMN 5 MAXIMUM PERIOD PERMITTED
Central Park Drive	West	A point 109 metres south of Peel Centre Drive and a point 120 metres south of Peel Centre Drive	Anytime	15

3. By-law 93-93 as amended, is hereby further amended by DELETING the word “Handicapped” and REPLACING it with the word “Accessible” in the title of Schedule XXI.
4. By-law 93-93 as amended, is hereby further amended by ADDING the following item to Schedule XXXVI:

PROHIBITED PEDESTRIAN CROSSINGS

COLUMN 1 INTERSECTION	COLUMN 2 LOCATION/DIRECT ION	COLUMN 3 TIMES OR DAYS
Private Driveway (8450 Torbram Road) and Torbram Road	East and west on the south leg	Anytime
