To Appoint a Temporary Integrity Commissioner and Repeal By-law 165-2019

WHEREAS sections 5, 8, 9 and 11 of the *Municipal Act, 2001*, authorize the Council to pass by-laws necessary or desirable for municipal purposes, and in particular paragraph 2 of subsection 11 (2) authorizes by-laws respecting the accountability and transparency of the municipality and its operations; and

WHEREAS subsection 223.2 (1) of the *Municipal Act, 2001*, as amended, provides that a municipality shall establish codes of conduct for members of the council of the municipality and of local boards of the municipality; and

WHEREAS subsection 223.3 (1) of the *Municipal Act, 2001*, authorizes municipalities to appoint an Integrity Commissioner who reports to Council and is responsible for performing in an independent manner the functions assigned by the municipality as set out in the *Municipal Act, 2001*; and

WHEREAS by By-law Number 165-2019 passed on July 10, 2019, The Corporation of the City of Brampton appointed Muneeza Sheikh as the Integrity Commissioner for the City of Brampton; and

WHEREAS City Council, at its March 11, 2022 Special Meeting passed Resolution C074-2022 to end the services of the Integrity Commissioner, and requested staff to explore the possibility to retain on a temporary basis the Integrity Commissioner for the Regional Municipality of Peel Council, to be appointed as the City's temporary Integrity Commissioner, in accordance with Section 223.2 of the *Municipal Act, 2021*, until such time as the City appoints a new Integrity Commissioner; and

WHEREAS City Council, at its April 6, 2022 meeting, passed Resolution _____ to appoint Principles Integrity as the City's temporary Integrity Commissioner, in accordance with Section 223.2 of the *Municipal Act, 2021*, until such time as the City appoints a new Integrity Commissioner;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

Appointment

1. Council hereby appoints Principles Integrity as the Integrity Commissioner for the City of Brampton, with all powers, duties and protections provided under the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended.

Short Title

2. This By-law may be referred to as the "Integrity Commissioner By-law."

In Force

3. This By-law comes into force on April 6, 2022
4. By-law 165-2019 is hereby repealed on the day this By-law comes into force.
