Updates



February 25, 2022 Government announced plans to introduce legislation to ensure workers in over 30 in-demand professions from other provinces can get their credentials processed within a service standard of 30 business days.

February 22, 2022

Introduced spring tape reduction package, the Fewer Fees, Better Services Act, 2022. Highlights include:

- Refunding licence plate sticker renewal fees paid since March 1, 2020;
- Establishing a single window for business services, which will require service standard guarantees so businesses can track the information they need from the government;
- Changing the government's approach to procurement to strengthen the province's supply chain;
- Creating a Centre of Realty Excellence to provide more flexibility related to provincial assets; and
- Removing tolls from Highways 412 and 418.

March 1, 2022: lifting capacity limits in all indoor settings; lifting proof of vaccination requirement


February 25, 2022 Federal, provincial and territorial labour ministers discuss common goals and collaboration as Canada emerges from the COVID-19 pandemic.

February 18, 2022 Announced \$10M in funding for the BlackNorth Homeownership Bridge Program to help deliver an estimated 200 affordable homes to first-time homeowner Black families in the Greater Toronto Area.

Highlights:

- Provincial budget to continue to address pandemic-related municipal costs
- No new unfunded responsibilities for municipalities and build for the future
- Account for inflation in cost-share programs

Call to Action:

- "Local share" capital donations in funding hospital construction and expansion released a proposed resolution for municipalities to consider in support of AMO
 call for the provincial government to re-examine hospital capital funding
- Joint and Several Liability AMO is asking municipal councils to lend their support to the 7 recommendations contained in the AMO submission to the Province
