Staff Comments (Planning):

- City staff are engaged with the Region and have no concerns from the City's perspective.
- There is a significant number of delegations and communications items on the committee agenda due to considerable opposition of Caledon residents to the settlement area boundary expansion.
- Regional comments to the Housing Affordability Task Force Recommendations align with the City's submission.



April 3, 2022:

The Premier was at Peel Memorial Centre to announce investment of \$21M to expand William Osler Health System.

- \$18M to plan Peel Memorial's transformation into a new inpatient hospital with a 24/7 emergency department.
- \$3M to expand cancer care services at Brampton Civic Hospital
 - Funding will help Osler plan to add new services for patients to access treatment and cancer care in Brampton.

Bill 109, More Homes for Everyone Act, 2022

- First step in implementing the recommendations of the Housing Affordability Task Force Report.
- Targeted policies for the immediate term in an effort to incentivize faster processing of certain applications to bring housing to market and increase transparency.
- If passed, Bill 109 would make a number of significant changes to the *Planning Act*, the *Development Charges Act, 1997*, the *City of Toronto Act, 2006*, the *New Home Construction Licensing Act, 2017*, and the *Ontario New Home Warranties Plan Act*.

Stakeholder Engagement

- The Province is seeking comments on the changes proposed under Bill 109, the proposed More Homes for Everyone Act, 2022. The deadline for submitting comments is April 29, 2022. Staff are reviewing the legislation and will be submitting comments on City's behalf.
- A Housing Supply Working Group will be set-up to engage with municipal and federal governments, partner ministries, industry, and associations. Staff will seek City's participation in this group.

2030 Emissions Reduction Plan: Canada's Next Steps to Clean Air and Strong Economy.

New climate target of cutting emissions by 40% below 2005 levels by 2030, and work toward a goal of net-zero emissions by 2050.

The Plan includes \$9.1B in new investments:

- \$2.9B towards EV charging infrastructure and financial support to make zero-emission vehicles (ZEVs) more affordable
- \$1B to develop a national net-zero by 2050 buildings plan, the Canada Green Buildings Strategy
- \$2.2B in expanding the Low Carbon Economy Fund

The Plan also includes commitments to help industries to adopt clean technology and transition to net-zero emissions as well as reducing oil and gas emissions.

The 2022 Federal Budget will be tabled on Thursday April 7 at 4:00 p.m.
