## MEETING LABOUR MARKET NEEDS

- According to Stokes Economics, over the next decade in Ontario, total demand for jobs that typically require a university degree is expected to rise by more than 925,000.
  - The supply of workers in STEM-based jobs that usually require a university degree will need to increase by nearly 200,000 (excluding the need for an additional 34,000 manager positions related to STEM-based fields).
  - Looming workforce shortages will increase competition across Ontario to fill these roles.
     Municipalities are making investments now to attract and retain top talent to their cities.
- Cities with a significant university presence will have an edge in the war for talent and attracting
  ongoing investment. Brampton has a history of investing in post-secondary education, recognizing
  its tremendous value.





## OUR COMMITMENT TO BRAMPTON

- Since June 2021, UofGH and City of Brampton staff have undergone extensive and positive conversations to identify required supports and business terms to advance the shared goal of relocating UofGH to Brampton starting in 2026.
- We have been meeting with community members and local organizations to understand Brampton's needs and to support their initiatives (Khalsa Aid winter clothing drive, CBC holiday food drive, Downtown BIA sponsorship, etc.)
- We have continued to update the Province on the potential relocation and prepare to meet approval requirements.
- We are committed to making significant investments to support the relocation and to work together to put a local stamp on the UofGH brand, making this truly Brampton's university.

### BRAMPTON'S COMMITMENT TO UofGH

To ensure the city's new university campus will provide students with a premier educational experience and create opportunities for local employers to connect with a critical talent pipeline, the relocation requires:

#### **CFI**

- University's total space requirement is 253,000 gross sq.ft. of which a minimum of 154,000 sq.ft. of dedicated
   & fitted out space should be in the CFI building
- Anticipating approx. 42,000 sq. ft. of additional fitted out shared space with the Brampton Library in the CFI building
- Lease and occupancy cost forgiveness for ten years

#### COMMUNICATIONS AND ENGAGEMENT

Support for transition related marketing/rebranding expenses
 Continued support with connecting UofGH to community partners

#### **EXTERNAL SPACE**

 A commitment to helping us secure external space of a minimum of 56,000 sq.ft. This space needs to be located within a 5-10 minute walk of the CFI and in condition to be occupied.

unique credential mix would support growing labour market demands in the city and would further reinforce Brampton's reputation as a leader in education and innovation.


