To amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), RATE OF SPEED (Schedule X), NO PARKING (Schedule XIV), NO STOPPING (Schedule XV), FIRE ROUTES (Schedule XXII), COMMUNITY SAFETY ZONES (Schedule XXIV), PAY AND DISPLAY ZONES, and NO PARKING LOADING ZONES (Schedule XXXIII)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, (“By-law 93-93”) as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending **THROUGH HIGHWAYS (Schedule III), RATE OF SPEED (Schedule X), NO PARKING (Schedule XIV), NO STOPPING (Schedule XV), FIRE ROUTES (Schedule XXII), COMMUNITY SAFETY ZONES (Schedule XXIV), PAY AND DISPLAY ZONES (ON STREET) (Schedule XXXII) and NO PARKING LOADING ZONES (Schedule XXXIII);**

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following item from Schedule III:
