8.1 Broadening Advocacy Priorities to Improve Housing Affordability In Peel (Recommendation)

Summary:

- A recommendation to broaden ROP advocacy to include several recommendations for improved housing affordability.
- <u>Staff Comments (Community Services):</u>
- City staff are generally in agreement with the intentions of the report, expansion of the Region's role and with the expanded advocacy priorities to be addressed by Provincial and Federal levels of governments.
- To continue to respond to the growing housing needs and to address the deliverables for action items of 'Housing Brampton' approved by City Council on May 19, 2021, there is a requirement of ongoing financial investment and support, as well as legislative action from senior levels of governments.

9.1 Private Noise Wall Conversion Program Review and Update (Recommendation)

Summary:

• A recommendation to broaden eligibility for the program, resulting in \$1M in additional, annual program expenditures.

Staff Comments (Public Works & Engineering):

- City staff support Regional recommendation, with option B being the most equitable, and providing the best balance of cost vs benefit to the residents.
- The recommendation would address issue of noise walls installed to mitigate noise from regional roads, where in many cases, there are City-owned lands between the Regional right-of-way and the noise wall. These should be the responsibility of the Region.

Summary:

 An update on implementation of Peel's Community Safety and Well-being Plan, including a list of undertaken activities.

- Community Safety & Well-Being Office (CSWO) participated in priority setting discussions to inform goals and key activities for 2022.

• City staff initiated discussions about public facing EV charge stations and weather the City should impose access control and/or user fees.
