8. Other New/Business

8.1 Discussion Item at the request of Rajbalinder Ghatoura, Co-Chair, re: Environment Advisory Committee Workplan

Rajbalinder Ghatoura, Co-Chair, outlined the following summary of responses from Committee members for the Environment Advisory Committee's 2022 work plan:

- Participate in person events (if allowed) and activities like tree planting, post COVID litter clean-up event, etc.
- Produce a digital marketing campaign and or bring awareness to some of the big environmental impact items. For example:
 - o transportation choices (cycling, walking, public transportation)
 - o eating less meat in our diet
 - o our energy consumption
 - o buying new instead of used
- Support the Brampton Environmental Alliance in its programs, events, and advocacy including membership and reach
- Support the City's "green vision" plans, by encouraging tangible actions and maintaining accountability with Council and staff
- Enlist Council support for Provincial environmental matters, (Example highway 413 and use of MZOs).
- Recruit and vet new BEAC members for the next Council term.

Committee discussion on this matter included the following:

- The need to establish a social media presence
- In-person event participation (e.g. tree planting, litter clean-ups)
- Producing a weekly newsletter to include information/articles on various environmental issues
- Indication that the proposed work plan is aggressive given the limited number of Committee meetings remaining in 2022, and the role of the EAC subcommittees in this regard
 - It was suggested that the EAC sub-committee meetings resume in order to achieve the objectives outlined in the proposed work plan
- Indication that the Terms of Reference for this Committee are action-oriented, and includes community outreach, raising environmental awareness in the community, and educating residents on the importance of the environment to our health and well-being

Clarification was sought regarding the intent of the last bullet point in the work plan to "Recruit and vet new BEAC members for the next Council term".

Sonya Pacheco, Legislative Coordinator, advised that the re-establishment of all citizen advisory committees are subject to Council approval in the new term, and provided a brief overview of the citizen appointments process.

Rajbalinder Ghatoura clarified that the intent is for the Committee to promote and encourage potential new EAC members for the next Council term.

The item was amended accordingly to read as follows:

"Promote and encourage potential new BEAC members for the next Council term"

8.2 Discussion Item at the request of Stacey Wilson, Committee Member, re: Urban Forest Management Plan Update

David Laing, Co-Chair, on behalf of Stacey Wilson, Committee Member, addressed Committee with respect to the Urban Forest Management Plan (UFMP), and outlined the following:

- A draft UFMP is posted on the City's website
- Clarification from staff is needed regarding the resources required to implement the UFMP, and it was noted that this information should be included in the plan
 - Michael Hoy, Supervisor, Environmental Planning, advised that a recommended structure and framework for the Urban Forest Management Section will be included in the plan
- Support from the Environment Advisory Committee for approval of the UFMP by Council
 - Michael Hoy, Supervisor, Environmental Planning, suggested that the Committee can demonstrate its support for the UFMP by way of a delegation at the time the report is presented to Council for approval
- Challenges in maintaining the existing tree stock, and concerns that without appropriate resources in place to support the UFMP, the tree canopy will not

thrive and the City will not achieve the objectives of the One Million Trees Program

- The need to educate residents and raise awareness on the importance of trees and the urban canopy
- Opportunity for residents to support the One Million Trees Programs by planting trees on their properties
- Indication that the maintenance of new trees is very labour intensive, and the UFMP should include further details on the resources required to ensure its success
- Indication that Brampton is behind other GTA municipalities in regard to forest coverage

City Councillor Whillans advised that a meeting with Forestry staff could be arranged to discuss the concerns raised.

8.3 Discussion Item at the request of David Laing, Co-Chair, re: City of Brampton Flexible Work Policy - Environmental Impacts

David Laing, Co-Chair, addressed Committee with respect to the environmental impacts of the City's Flexible Work administrative policy, which includes a gradual return to in-person work. David's remarks included the following:

- Indication that this policy does not align with the City's Climate Emergency declaration or the Community Energy and Emissions Reduction Plan (CEERP)
- Concern that this policy delivers the wrong message to the community that the Climate Emergency is not a priority
- Concern regarding the impact of this policy on the carbon footprint of employees daily commute to work
- Dire climate predictions in the most recent report of the Intergovernmental Panel on Climate Change, and the need to take action to reduce carbon emissions
- Questions regarding the justification of this policy, and a suggestion that this
 policy be reviewed by Council and overturned

In addition, David Laing outlined the following questions for the City's senior administrators:

- a. What is the justification for implementing this policy change?
- b. Has this policy been reviewed and approved by Council?
- c. How does the Administration square the increased carbon emissions resulting from this change with the City's Community Energy and Emissions Reduction Plan?

Committee discussion on this matter included the following:

- Questions regarding the availability of this policy on the City's website for public review
- Request for clarification from senior staff on the necessity of this policy
- Concern that this policy fails to communicate the seriousness of the Climate Emergency
- The opportunity provided by the COVID-19 pandemic to change employment habits
- Concerns from taxpayers regarding staff working remotely
- Management philosophies and tools relating to remote work, which can be used to demonstrate its effectiveness

Peter Fay, City Clerk, provided information to Committee regarding the implementation of remote work at the City of Brampton due to the COVID-19 pandemic, and the phased-in approach for employees returning to work inperson. Mr. Fay added that the City has modernized its flexible work program to include remote work as an option for employees, if it can be accommodated based on the nature of work.

The following motion was considered.

c. How does the Administration square the increased carbon emissions resulting from this change with the City's Community Energy and Emissions Reduction Plan?
