Dear Jeanie,

This letter is in reference to the proposed changes in Application # B-2021-0018 and Application # B-2021-0019 at Ward #10. We, the undersigned residents of this area would like to request that these proposed changes should not be approved due to the following reasons-

1. This area has been vacant since the houses in this area were built and has been used by the neighbourhood kids to play in the evenings while being under the observation of their parents who often sit on their front porches to observe them live their childhood.
2. This subject area is on the curve of the property, which if converted into two additional houses will add more traffic to the already busy curve leaving no open space for the houses to park guest cars.
3. This is a mature neighbourhood with well settled houses and greenspaces, and bringing in the construction material to build two new houses will not only make it a different look a for existing houses but also cause disruption to the daily routine of the families living in the neighbourhood. It will add noise pollution, air pollution and construction safety hazards for the kids. We will have to keep our windows closed, kids inside and bear the dirt and construction mess.
4. The construction will take few months or a year or more and that means that we cannot live a normal life or sit outside to enjoy the weather due to construction right next door.
5. There is no point after so many years of not building anything on this property that now it is being converted by causing distress and disturbance to a well settled neighbourhood.
6. There is no open space or green area in the entire block other than this plot of land and making houses on this also, leaves no option for neighbours to gather and stand to talk, kids to play and stay off the roads. Converting this land will increase the road traffic, add discomfort to road users and also enhance risk of accidents due to less space available for moving out of the way.

Considering the above, we request you to kindly look into this application based on these concerns.
