#### 8. Other/New Business

8.1 Discussion at the request of Ziggy Musial, Member, re: Construction Update - New Sports Hall of Fame at Victoria Park Arena/Complex

Teri Bommer, Coordinator, Sport Liaison, provided an update on the construction of the New Sports Hall of Fame at Victoria Park Arena. Highlights included the following:

- City is close to sign completely on the construction design
- Project tender process is expected to begin by summer of 2022 with construction anticipated in fall of 2022
- Spring of 2024 is the projected date of completion and opening of the building is anticipated for summer of 2024
- Building Sub-committee and staff met on April 21, 2022 with design consultant Reich & Petch who has been hired for the 'fit design' of the building
  - goal to complete work for building opening
- Next Steps include
  - o consolidation of inventory
  - photographing all assets Ron Noonan and Teri Bommer to undertake this task
  - Noting historical significance of each asset
  - Identifying which items are "musts" to be displayed
  - o Identifying which assets are related to an inductee
  - deciding what key sports are to be highlighted

Ms. Bommer advised that once consolidation of inventory is completed an email will be sent to members for input and feedback. The information will be compiled and shared with the curatorial consultant.

Committee discussion took place and including the following:

- clarification on key sports should include significance of the sport and its history
- comment that sports' trends change and reference to cricket becoming a major sport in the City
- advised that a number of artifacts (71) are stored at Ron Noonan's home and some are stored at the CAA centre
- Question whether all items can be listed on the Sports Hall of Fame website

- small items can be listed on a digital keypad, images of artifacts that are related to an inductee will be added to their profile and available for viewing
- o intent is to put all items on a digital platform to make available to the public
- Indication that anticipated new Sports Hall of Fame will be available to host the 2025 Induction Ceremony
  - 2024 event will be much like the 2022 event if timelines remain unchanged
  - construction timelines will determine whether the 2024 event can take place at the new site

8.2 Discussion at the request of Teri Bommer, Coordinator, Sport Liaison, re: Induction Ceremony review/feedback

Teri Bommer, Coordinator, Sport Liaison, referenced the 41<sup>st</sup> annual Induction Ceremony at the Rose Theatre held on May 3, 2022 and reminded Committee that following the 2022 Induction event, they were expected to provide feedback on ways to improve, modernize and refresh the event for next year. She suggested that feedback on topics, such as, programme changes, and layout and the guest speaker would be helpful.

Discussion took place and included the following:

- ticket count was approximately 90 patrons
- past inductees were all sent invitations
- attendance was poor
  - need to reach out to youth organizations and encourage the purchase of tables

- · event was well organized
- speeches by nominees and nominators were too long and should be timed
  - o audience interest was lost
  - speakers went over the time limit
- keynote speaker was well informed and engaged
- need to reach out to youth organizations and encourage participation and support of the event
- differing opinions on whether Committee members should be on stage to present certificates to inductees
  - suggestion that this topic be listed for discussion at the next meeting
- indication that inductees prefer to have presenters on stage who have supported them throughout their career
- suggestion to publish the names of Committee members on the Sports Hall of Fame website
- consider past inductees who may have interesting stories to share as a guest speaker

Ms. Bommer thanked members for their input and reminded them that feedback provided at the event Sub-committee meetings while the event is in its planning stages will be helpful. She noted poor participation at the meetings leading up to the 2022 event. An email will be sent to members for any further input they may have.
