# Provincial Government | Update

**April 30, 2021:** The Long-Term Care COVID-19 Commission has publicly released a final report.

**April, 30, 2021:** Released Ontario's Digital and Data Strategy, *Building a Digital Ontario*.

**April 29, 2021:** Introduced legislation that will require employers to provide employees with up to \$200 of pay for up to three days if they are missing work because of COVID-19. The program will be retroactive to April 19, 2021 and effective until September 25, 2021, the date the CRSB will expire.

**April 29, 2021:** Announced phase two schedule for COVID-19 vaccine rollout and eligibility.

**April 28, 2021:** Amended O. Reg. 272/21 under the Emergency Management and Civil Protection Act (EMCPA) to ensure patients receive quality care in the most appropriate setting during the third wave of the pandemic, driven by variants of concern.

**April 28, 2021:** Announced \$86M to help train up to 8,000 personal support workers (PSWs) through private career colleges and district school boards.

## Analysis Report

WHETHER TO DESIGNATE THE GTA WEST PROJECT IN  
ONTARIO PURSUANT TO THE IMPACT ASSESSMENT ACT

**May 3, 2021:** The Minister of Environment and Climate Change has determined that the GTA West Project proposed by the Ontario Ministry of Transportation **warrants designation under the Impact Assessment Act.**

Rationale for the decision:

- The designation of the Project is warranted as the Project may cause adverse direct or incidental effects on the critical habitat of federally-listed species at risk.
- The Minister took into account the public concerns related to these potential effects.

City of Brampton Staff Comments:

- The decision does respect Council's request in the motion dated March 3, 2021 that the GTA West project be designated.
- At this point in time it is not clear when the federal study will start, how it will proceed, or when it will conclude.
- Staff will identify opportunities to be involved in the study.

Staff will provide Council with updates as appropriate.

## May 3, 2021: Official launch of Brampton Transit's electric buses

- The largest single global deployment of standardized and fully interoperable battery electric buses and high powered overhead on-route charging systems.
- Federal Minister of Infrastructure joined Members of Council, Brampton Members of Parliament and stakeholders for an official launch event this past Monday.
- Eight (8) battery electric buses, two (2) from Nova Bus and six (6) from New Flyer entered service on May 4.
- In 2019, the Federal government announced \$11.15M towards this first phase of the pilot project.
