# BY-LAW

To Appoint Three Additional Regional Councillors  
for the 2022-2026 Term of Council

---

WHEREAS the Council of the Regional Municipality of Peel enacted By-law 83-2020, pursuant to Section 218 of the *Municipal Act, 2001*, as amended; and

WHEREAS the effect of Regional By-law 83-2020 is to change the composition of the Region of Peel Council to establish nine (9) members from the City of Brampton, effective for the 2022-2026 Term of Council, comprised of the Head of Council and eight (8) other persons selected in such manner as the City of Brampton may, by by-law, specify; and

WHEREAS City By-law 66-2013 establishes the composition of City Council, including, in addition to the Head of Council elected by general vote:

- five (5) elected members called Regional Councillors, elected by wards in accordance with By-law 66-2013, as members of both the City Council and Council of the Regional Municipality of Peel, and
- five (5) elected members called City Councillors, to be elected by wards in accordance with By-law 66-2013, as members of City Council only; and

WHEREAS The change in composition of City of Brampton representation at the Region of Peel Council now allows for three (3) additional members to be appointed from among the 5 elected City Councillors; and

WHEREAS Procedure By-law 160-2004, as amended, provides for additional Regional Councillors to be appointed from among the five elected City Councillors following a municipal election, for the 2022-2026 term of the Council; and

WHEREAS the procedure to select the three (3) additional Regional Councillors, pursuant to the Procedure By-law, was conducted at a Special Council Meeting on November 16, 2022; and

WHEREAS the following three (3) City Councillors were selected through that process:
