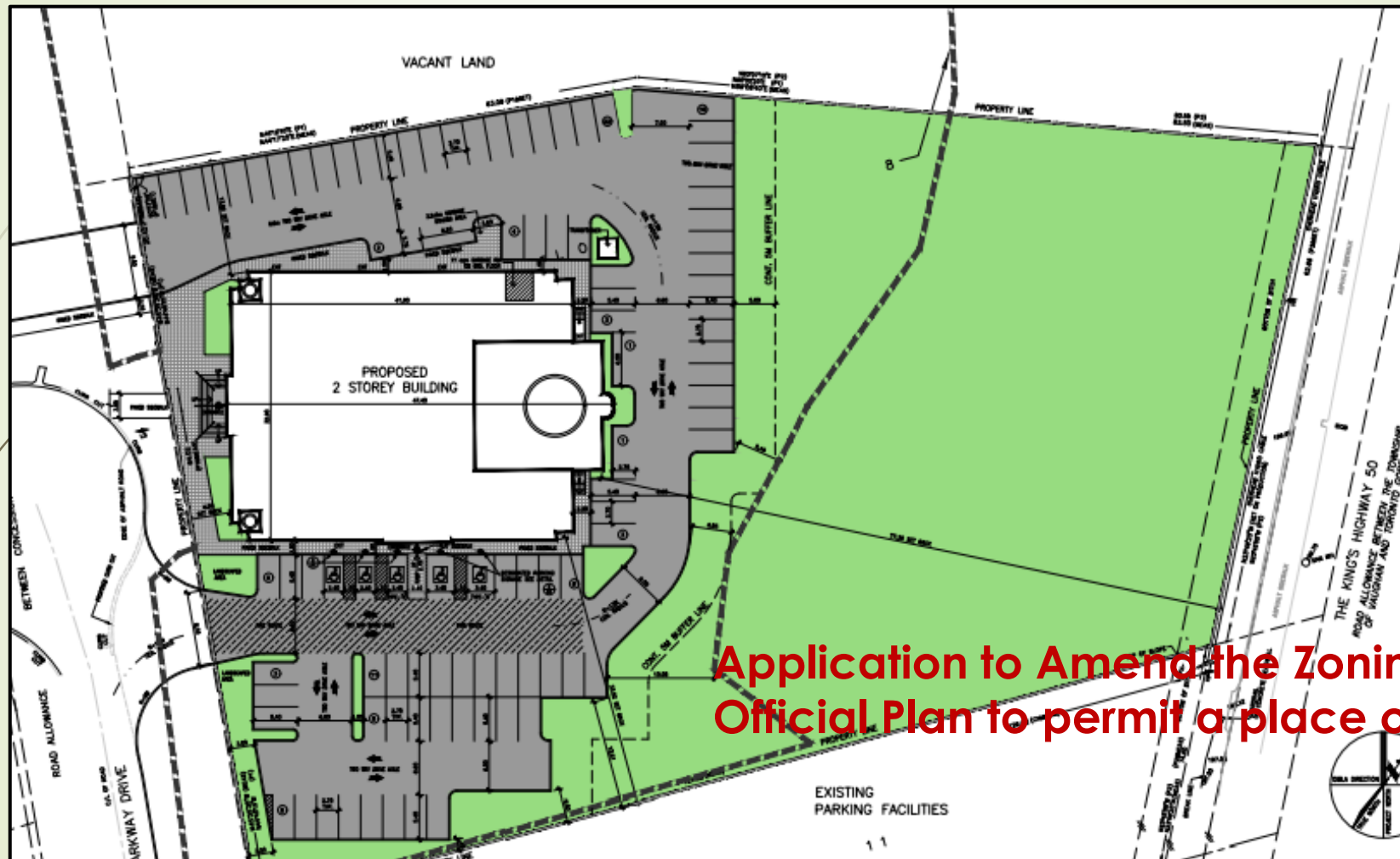

My name is Rahmatullah Habib, representing BARIC in this meeting. Thanks for giving me the opportunity to speak in support of BARIC project. I am pleased to present you an overview of BARIC and the proposed Centre.



About BARIC

- ❑ **Brampton And Regional Islamic Centre (BARIC) is a non-profit and charitable organization.**
- ❑ **Existing Centre located at 4525 Ebenezer Road (Unit 3, 4 & 5), Brampton.**
- ❑ **Centre has two small prayer halls, one for men & one for women.**



Programs and Services

- ❑ Provides religious and community services for a large population living in East Brampton & surrounding areas since April 2013.
- ❑ Plays an important role by providing humanitarian aids to various Charitable & Relief Organizations, Hospitals, Foundations, and others. This year, it helped Fiona victims in Canada & Flood victims in Pakistan.
- ❑ Actively participates in environmental & other community activities including tree planting.
- ❑ Offers daily & Friday prayers, religious classes & gatherings, Ramadan & Eid programs, and summer & recreational programs.



Community Engagement

- ❑ **BARIC maintains a very good relation and is living peacefully with its neighbors for last 10 years.**
- ❑ **One of its visions is to promote and maintain interfaith peace, trust & harmony, and support others as needed.**
- ❑ **Provides opportunity for diverse members to come together and get to know each other, share foods, and celebrate religious festivities with families.**
- ❑ **Creates foundation to help others , especially those who are struggling in difficult times regardless of ethnicity, colour and race.**

Why We Need New Centre?

- ❑ No Mosque in the large area of East Brampton and neighboring areas.
- ❑ Regular presence of families in existing Centre increased rapidly when it became necessary to get a larger place to meet the demand of the community.
- ❑ Existing Centre is small and located in a commercial plaza having no facilities/separate rooms/areas for running programs and serve the families.
- ❑ To meet the demands, BARIC purchased the land at 9445 Clarkway Dr. to build a complete Centre with all required facilities.



Benefits of New Centre

- ❑ **Proposed Centre will have all facilities including prayer hall, gymnasium, exercise room, library, place for senior citizens, classrooms, kitchen with social gathering & eating area including other facilities which will facilitate BARIC to meet the growing demand of community.**
- ❑ **Offer additional services (counseling etc).**
- ❑ **Specific focus on programs for adolescent and youth to develop a well motivated life towards humanity and good causes.**
- ❑ **Centre will play a key role to bring peace and harmony in region and contribute to build a safer community.**

Development Applications

- ❑ **BARIC submitted Official Plan & Zoning By-law Amendment applications for construction of the new Centre.**
- ❑ **1,928 members of BARIC community have signed a petition and submitted to the City supporting the project of building the new BARIC Centre, many of them are present here.**
- ❑ **We trust, City is aware of the importance and will act diligently to facilitate approval of this project.**
