David Monaghan, Supervisor, Traffic Planning, Public Works and Engineering, provided a presentation entitled 'Bike Lanes in School Areas'.

Committee discussion on this matter included the following:

- Whether it is a violation for vehicles to park on bike lanes such as on McMurchy Avenue
  - lane has to be a designated 'bike lane' for vehicles to be considered in violation
  - McMurchy Avenue is not considered a designated bike lane

- Clarification on the green markings with the bike emblem
  - information on parking and fees for violations
- Request for statistics on usage of bike lanes during summer and winter are unavailable - staff is working on options to collect this type information
- Question regarding bike lanes around Gordon Graydon Public School - right turns on Vodden Street and a suggestion that pedestrians be educated on safe crossing practices
