1.0 Purpose:

The purpose of this amendment is to amend Schedule 5 from the Highway 410 and Steeles Secondary Plan (SPA 5) to revise the land use designation from General Employment 2 to Prestige Employment.

2.0 Location:

The lands subject to this amendment are located on the west side of Highway 410 and south side of Steeles Avenue E., and are municipally known as 150 First Gulf Boulevard. The lands comprise of 1 parcel totaling 0.03 hectares in area, and have a frontage of approximately 41 metres on Biscayne Crescent and are legally described as Part of Lot 15, Concession 2, E.H.S.

3.0 Amendments and Polices Relative Thereto:

- 3.1 The portions of the document known as the 2006 Official Plan of the City of Brampton Planning Area, which remain in force, as they relate to the Highway 410 and Steeles Secondary Plan, being Chapter 6, of Part Two of the City of Brampton Official Plan, as amended, are hereby further amended:
