- Training for new Board members to include:

 - Designation of properties
- Approval of a permit for a garage at 43 Chapel Street which meets the criteria for designation - heritage impact assessment not required
- Placement of the plaques in Gage Park has been delayed due to construction
- Event planned for July 2023 to present plaque to home owners and celebrate the contribution of past Board members who may not be returning
