# BY-LAW

**To amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), RATE OF SPEED (Schedule X), U-TURNS (Schedule II) and NO PARKING (Schedule XIV)**

---

WHEREAS the Council for The Corporation of the City of Brampton has adopted Traffic and Parking By-law No. 93-93, (“By-law 93-93”) as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the Municipal Act 2001, a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), RATE OF SPEED (Schedule X), U-TURNS (Schedule II) and NO PARKING (Schedule XIV)

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

## **THROUGH HIGHWAYS**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Tango Road	The south limit of Lacoste Boulevard and the north limit of Cultivar Road
Tango Road	The south limit of Cultivar Road and the north limit of Lauderhill Road

2. By-law 93-93 as amended, is hereby further amended by ADDING the following item to Schedule III:

**THROUGH HIGHWAYS**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Tango Road	The south limit of Lacoste Boulevard and the north limit of Lauderhill Road

3. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule IV:

**STOP SIGNS**

Tango Road and Cultivar Road	Southbound on Tango Road
Tango Road and Cultivar Road	Northbound on Tango Road
Tango Road and Cultivar Road	Westbound on Cultivar Road

4. By-law 93-93 as amended, is hereby further amended by DELETING the following item from Schedule X:

**RATE OF SPEED**

James Potter Road	East	A point 115 metres north of Bonnie Braes and a point 230 metres north of Bonnie Braes	Anytime

James Potter Road	East	Bovaird Drive West and a point 115 metres south of Williams Parkway	Anytime
James Potter Road	East	A point 50 metres north of Roundstone Drive and Steeles Avenue West	Anytime
James Potter Road	West	Bovaird Drive West and Steeles Avenue West	Anytime
