Karamjot Sodhi,

As discussed, the Harkarit Singh campaign Form 4 which had been submitted to the City on March 31, 2023 incorrectly reports a contribution. The campaign does have an extended reporting period and will require an updated Form 4 to be filed to report subsequent transactions to June 30, 2023. A correction will be included in the updated Form 4.

There were two separate contributions of \$1,000 each included in the calculations for total contributions. One contribution was from Surinder Ahuja and the other was from Sunita Ahuja. The receipts for the contributions correctly reported the two different contributors.

An error in Part III of the Return incorrectly identifies two separate contributions of \$1,000 each corresponding to Sunita Ahuja. A correction will be required to properly show the two different contributors as \$1,000 contributed by Surinder Ahuja and the other \$1,000 from Sunita Ahuja.

I have attached the pdf copies of the original cheques and the contributors' receipts. The Schedule III is also included to show the highlighted error.
