Please see the attached correspondence sent to Mr. Cody Vatcher on Monday June 26, 2023.

The letter provides a brief explanation of why my in-kind contribution did not exceed the allowable limit of \$1200 as prescribed in the Municipal Elections Act.

I believe Mr. Vatcher erroneously listed the full purchase price of 500 lawn signs in his campaign financial filing and not the value of the 499 signs actually donated in-kind to his campaign. The unit cost per sign was \$2.41. As an experienced political operative, I purposely withheld one sign and kept it in my possession in order not to exceed the contribution limit. That sign is still in my possession. (See APPENDIX I) Thus, my donation was \$1198.00.

If allowed, I expect Mr. Vatcher will take the opportunity afforded to him to amend his filing in order to accurately reflect my modest donation to his campaign.

It is my assertion that I did not contravene section 88.9 of the Municipal Elections Act. The candidate unwittingly reported my in-kind contribution incorrectly. I am asking you to find that I did not contravene the Act.
