Reasons for Objections

This street is zoned to have bike lanes, sidewalks and road widening to the hospital - this is not in line with the vision as they are constantly blocking the road, driveways and parking in no parking zones and in front of safety fire hydrants with often detaching the trailer to stay there without a cab in front of the hydrant for days to weeks at a time.

We are an autobody repair facility and when people are in auto accidents they already become very taumatized & nervous drivers. These trucks currently are breaking bi-laws blocking our driveway, parking in front of our business and business beside us when it is a no parking zone and blocking the vision of oncoming vehicles which tend to go very fast down this road. The elderly are becoming particularly concerned & nervous to come to our shop which have been long time clientele. The trucks are parking or stopping for long periods in the no parking area, usually hours, blocking vision to our company name so people phone and say they went somewhere else because they couldn't find us or didn't feel safe moving in or out of our lot as you can't see if a vehicle is coming because the trucks are parked along the road - this is a huge hazard. Bi-law is sometimes here but does not action anything as the trucks continue to park there with bi-law parked in front of the building asking for the permit - not sure if a relationship has been established given this.

If a company (there are pictures) of the **Truck Driving School parked facing the wrong direction of traffic (wrong side of the road)** as well as in a **no parking zone** as well as right up to or **blocking the driveway** which creates a high situation for an auto accident pulling out - why should they be teaching **others the illegal bad habits**?

Trucks currently parking regularly

- We finish our repairs with the washing of vehicles and they constantly go by driving on the shoulder stirring up a cloud of dust and the vehicles are then again not clean and unprofessional to deliver to Clients tarnishing our reputation of excellence.
- Complete blocking or partial blocking our driveway dangerous for Employees and Clients to exit the driveway as it is a visual barrier for oncoming vehicles
- Parking and idling in front of our business in a No parking area which blocks our company name making it hard to find
- Trucks continually stopping and parking on the wrong side of the road
- Trucks parking and also unloading their trailers to leave in front of the fire hydrant or in the no parking zone

There is a constant neglect for the City Laws and we feel with the extra permissions that it will escalate.

• Inadequate employee parking - constant parking on road in all directions in a 3 hour bi-law limit, sometimes 2 cars wide on the *narrow* road


They park on the road lateral and diagonal as well as trucks often parked on the road side by side - often 2 trucks on one side and one on the other making local traffic extremely difficult to travel through. Blocking the road with trucks while truck attempt to back in which is never immediate. Employees not looking before they exit from parking and have almost caused a few accidents.

• Listed in the Application the photo shows that the property is surrounded by fence - there is no fencing.

Busy street and the trucks and training trucks will not pull out from our current street to Hanson or Kennedy often creating a large back log of vehicles behind them for an extended time. Jumping out to get a lunch or trying to get home can sometimes wait 10-15 minutes to turn with them at the stop sign - this is not practical. In the mornings we have Clients that need to drop their vehicles and get right to work and it is becoming difficult.

Also vehicles speeding through the street - very fast to these business













